The Greater Monterey County Regional Water Management Group wholeheartedly supports the Environmental Justice Coalition for Water (EJCW) in their proposal to implement the State and Local Smalls Interim Drinking Water Pilot project for the Central Coast Water Board. Due to the serious nitrate contamination of drinking water wells in Northern Monterey County, this pilot project will focus on outreach, planning and implementation of an interim drinking water solution in the communities of Springfield Terrace, Las Lomas and in the surrounding area. This project will support these disadvantaged and severely disadvantaged communities who are in need of a safe supply of drinking water.

This pilot is similar to the work that EJCW and partners have been doing for the Greater Monterey County Integrated Regional Water Management (IRWM) region. For the last several years, the Regional Water Management Group has been implementing an IRWM Planning Grant for the Greater Monterey County region. EJCW and partners have played a critical role in that grant in their efforts to work directly with disadvantaged communities. Deliverables they have been responsible for include: a DAC outreach plan for the region, a DAC and Tribal Needs Assessment, identification of critical water and waste water projects, and technical assistance to get DAC projects submitted into the IRWM Plan.

EJCW and partners have been very resourceful and responsive in these efforts. They are extremely professional and very easy to work with given demanding conditions and schedules.
