## **Violations Listing**

Staff uses the California Integrated Water Quality System (CIWQS) to track Water Board data, including violations and enforcement actions. Attachment 1 is a CIWQS list of violations by dischargers between November 1, 2013, and February 28, 2014. CIWQS has a sewer system overflow (SSO) module that provides tracking and reporting of such spills.

## Significant or Notable Violations

- California Men's Colony, San Luis Obispo County. CMC reported 75 violations for November through February. Most appear to be related for chlorine disinfection. However, the new ultraviolet disinfection system came on line January 23, 2014. We expect a significant decrease in violations going forward.
- Cal Poly San Luis Obispo. Cal Poly has experienced three failures of its hot water piping system, resulting in discharges of hot, chemically treated water to local creeks. Enforcement staff is following up.
- Imerys Minerals, Lompoc, Santa Barbara County. Pump failures caused large volume spills
  of diatomaceous earth slurry to San Miguelito Creek. Enforcement staff and Department of
  Fish and Wildlife are following up.
