Dear Chairman Wolff and Board Members:

I am writing you today to express our support for the Morro Bay National Estuary Program's spending proposal for the future of the Consent Decree funds under their guardianship Since 1997, these funds have helped support important estuarine and watershed conservation work within the Morro Bay area. As a result, the Estuary Program has leveraged \$9.35 million for water quality and habitat protection. There is a continued need for these funds to implement the Estuary Program's management plan and worthy projects identified for future spending.

The Coastal San Luis Resource Conservation District (RCD) is a leader in on-the-ground conservation efforts. Our relationship with the watershed community and the Estuary Program spans more than 20 years. In that time, we have been involved in numerous conservation projects including the Chorro Flats Floodplain Restoration, Project Clearwater, and Morro Bay Agricultural Water Quality Enhancement Program.

The Coastal San Luis RCD received over \$620,000 of Consent Decree funds to implement water quality projects. The funds are integral to showing local engagement and management of watersheds. The majority of the funds received went to Project Clearwater supporting implementation of over 150 best management practices (BMPs). These projects included installation of off-creek watering systems for cattle and corresponding riparian fencing, stream head-cut remediation, road improvement to prevent erosion, and habitat enhancement for steelhead trout and red-legged frogs. The project resulted in protection of over 52,000 feet of stream bank and the stabilization of 50 feet of stream bank. Improvements included over 51,500 feet of riparian fencing, 17 watering troughs/tanks, 74,592 feet of pipeline, 2 stream crossing improvements, 1 fish passage improvement, and over 21,000 feet of vegetation management and debris removal. Altogether, these implementation projects will provide estimated benefits to the Morro Bay estuary and its watershed, over a ten year period, of reduction in sedimentation by 9,014 tons, and prevention of deposition into streams of over 421 tons of manure, with a corresponding reduction in nitrogen input of 5,558 pounds, and of phosphorus input of 455 pounds, as well as large reductions in fecal coliform and fecal streptococci

In the future, Consent Decree funds could support additional projects in partnership with the Coastal San Luis RCD such as stormwater management and water conservation. These projects would help the watershed community move toward climate readiness, improving the resiliency of water sources for all (agriculture, environment, and urban)

I urge you to support the Estuary Program's spending plan and to support their continued custody of these funds.
