DISCUSSION

Violations Listing

Water Board staff uses the California Integrated Water Quality System (CIWQS) to track Water Board data, including violations and enforcement actions. Attachment 1 is a CIWQS list of violations by dischargers between June 1, 2015 and September 30, 2015. CIWQS has a sewer system overflow (SSO) module that provides tracking and reporting of such spills.

Summary of Enforcement Activities

The following information summarizes enforcement actions taken by the Water Board during the period between August 1, 2015 and November 30, 2015.

Notable or Bulk Enforcement Actions

- In December 2015, Irrigated Lands Regulatory Program (ILRP) staff sent 70 notices of violation letters to growers who failed to submit total nitrogen applied forms by the October 1, 2015 required date. The total nitrogen applied form was required through a 13267 order issued in the summer of 2015. In some of these cases, the grower also failed to submit an annual compliance form. ILRP staff continues to work with these growers to achieve full compliance.
- On September 16, 2015, the Industrial Stormwater Program issued first notices of noncompliance letters to 19 facilities for failure to submit annual monitoring reports by August 14, 2015, as required by Order No. 97-03-DWQ, NPDES General Permit No. CAS000001, Waste Discharge Requirements for Discharges of Storm Water Associated with Industrial Activities (expired July 1, 2015, but remains effective for the purpose of enforcement).
- On October 26, 2015, the Industrial Stormwater Program issued second notices of noncompliance letters to 12 facilities for failure to submit annual monitoring reports by August 14, 2015, as required by Order No. 97-03-DWQ, NPDES General Permit No. CAS000001, Waste Discharge Requirements for Discharges of Storm Water Associated with Industrial Activities (expired July 1, 2015, but remains effective for the purpose of enforcement).
- On November 20, 2015, the State Water Board issued 44 notices of non-compliance letters to Industrial Storm Water Program permittees that failed to recertify their Notices of Intent to Comply (NOI) – Waste Discharger Identification numbers (WDIDs), or that

did recertify but failed to upload their Storm Water Pollution Prevention Plans (SWPPPs) and/or Site Maps, as required by State Water Board Order 2014-0057-DWQ, NPDES General Permit No. CAS000001, Waste Discharge Requirements for Discharges of Storm Water Associated with Industrial Activities (replaced Order No. 97-03-DWQ effective July 1, 2015).

- Laguna County Sanitation District, Santa Barbara County \$38,832 penalty for a sanitary sewer overflow in violation of WDR Order No. 2006-0003-DWQ and the Clean Water Act.
