

- Ag Order 4.0 development accelerated



2017 Monitoring (slide from Webcasts and Workshops)

- Notification on the following is coming
- Groundwater monitoring required
 - Primary irrigation well
 - All domestic use wells
 - 2 samples from each (1st: March-June; 2nd Sept-Dec)
- Inclusion in surface receiving water requirements:
 - Pyrethroids
 - Neonicotinoids
 - Hyalella (sensitive to pyrethroids)
 - Chironomus (sensitive to neonicotinoids)

Monitoring and Reporting Programs for 3.0

- Current MRPs written for 2017
- Must Develop MRPs for Term of 3.0
- 3.0 MRP Components considering:
 - Groundwater monitoring: frequency
 - Pesticide monitoring: pollutants, frequency and timing
 - Toxicity: Indicator species, frequency and timing
- Other Considerations
 - Cost
 - Value
 - Flexibility

Staff Considering for 3.0 Seeking Board Input Today

- Total Nitrogen Applied Requirement
 - Expand requirement to others
- Term of Ag Order 3.0
 - Less than five years
