WATER BOARD'S RACIAL EQUITY INITIATIVE

Introduction

The high-profile incidents of social unrest and police violence against Black Americans in recent months have sparked nationwide protests and renewed calls to eliminate systemic racism. Recognizing this critical challenge to achieve racial equity, the State Water Board's Executive Director, Eileen Sobeck, is committed to leading the organization in an effort to respond and implement changes to ensure the Water Boards' policies and programs are equitable and just for all Californians.

In August 2020, the State Water Board directed staff to implement the Racial Equity Initiative and convene a Racial Equity Steering Committee and Working Group. The Racial Equity Steering Committee includes eight members representing the Water Boards and one member representing CalEPA; Their primary responsibility is to ensure the Water Boards remain committed to advancing racial equity and to direct the Working Group's progress on implementing the following priorities: 1) Establish a foundation of internal and external engagement that values listening and collaboration to drive action, 2) Draft, vet and finalize a resolution on racial equity to be considered for adoption by the State Board and also leveraged by Regional Water Boards to adopt their own resolutions, and 3) Develop racial equity strategies and action plans to drive efforts for the coming years. The Working Group includes approximately 20-25 Water Board employees; Angela Schroeter represents Region 3.

As an initial step, the Racial Equity Steering Committee and Working Group held four community listening sessions to gather input from external stakeholders in November and December 2020.

INTEGRATED REPORT UPDATE

Introduction

This is an informational update regarding the status of the Integrated Report for the listing cycle year 2020/2022. The Integrated Report includes the federal Clean Water Act section 303(d) List of Impaired Waters and section 305(b) Surface Water Quality Conditions Report. The Clean Water Act section 303(d) List identifies waterbodies that do not meet one or more water quality standards and are therefore "impaired." Clean Water Act section 305(b) requires states to report to USEPA on the condition of its surface water quality, including both impaired waterbodies and those that are attaining water quality standards.

Process and Schedule

In January 2021, Central Coast Water Board staff will complete data assessments and fact sheets for over 7,500 waterbody and pollutant combinations. The State Water Board will administer the public process on behalf of the Regional Water Boards. Although this eliminates the Regional Water Board approval process, the Central Coast Water Board staff is tentatively planning to host a public workshop in May or June of 2021 (during the State Water Board's public comment period). While members of the Central Coast Water Board may be present, no formal action or decisions will be taken by the Central Coast Water Board at this workshop.

The table below describes key tasks for Central Coast Water Board staff and opportunities for public participation in the 2020/2022 Integrated Report approval process. The schedule may change slightly but is the best estimate based on the State Board timeline as of December 2020.
