5. Report by State Water Resources Control Board Liaison [Sean Maguire, 916/341-5877, <u>Sean.Maguire@waterboards.ca.gov</u>]

State Water Board Member, Sean Maguire, provided updates by Zoom on the following: welcomed new board member Alex Rodriguez, and encouraged everyone to take part in earth day this Saturday; nutrient management and associated impacts to groundwater and surface with an emphasis on ocean acidification and hypoxia in our coastal waters and associated research by the Southern California Coastal Water Research Project (SCCWRP) to evaluate the relative effects of climate change and NPDES permitted discharges and the potential benefits or unintended consequences of nutrient treatment upgrades and increased wastewater recycling; March 21, 2023, workshop titled "Drought Update and Current Hydrologic Conditions"; May 18, 2023, workshop titled "Statewide Nutrient Management"; climate change and hydrologic uncertainty transitioning from drought to floods: Governor's Office roll back of drought emergency executive orders and transition to flood related executive orders and the promotion of using flood flows for groundwater recharge to help address groundwater sustainability and water supply resiliency while mitigating flood impacts; forthcoming annual drinking water needs assessment update including refined metrics focused on disadvantage community needs and the human right to water: wastewater needs assessment development process; climate change and aging infrastructure related challenges for small water communities, and; communities impacted by flooding.

The Board members thanked Mr. Maguire for his presentation and engaged with him regarding the significant coastal footprint of the central coast region and the importance of Marine Protection Areas, fisheries management, mapping and coordination with the California Coastal Commission and other entities regarding ocean acidification and climate change.

#### **Enforcement**

6. Consideration of a Proposed Resolution to Refer Big Basin Woods Subdivision Wastewater Treatment Plant Matter for Formal Enforcement to the California Attorney General

Mr. Keeling introduced the item. Tamara Anderson, Central Coast Water Board enforcement coordinator, and Paul Ciccarelli, State Water Board Office of Enforcement attorney, provided an overview of the facility, summarized the alleged

violations and coordination with other entities and community members, explained the California Attorney General referral process and potential remedies through that process, summarized written public comments, and recommended approval of the proposed resolution to refer the Big Basin Woods Subdivision wastewater treatment plant to the California Attorney General for enforcement along with proposed edits included in a supplemental sheet.

Board members asked about the Attorney General's implementation timing. Mr. Ciccarelli indicated that staff would mark the referral urgent, but the timing of actions is uncertain. Board members also inquired about actions taken since the CZU Complex fire damaged the facility in 2020 and potential opportunities to provide interim relief to the community members while addressing the larger problem with a long-term solution.

In response to Board members questions and during public comments, Santa Cruz County staff explained their understanding of current facility conditions, the County's processes for issuing permits to Big Basin Woods Subdivision property owners, and the County's current involvement related to the inoperable wastewater treatment plant and associated alternatives. Santa Cruz County Supervisor Bruce McPherson supported the proposed resolution and stated that he hopes to see a receiver appointed for both water and wastewater services.

In response to Board inquiries, Big Basin Water Company owner Thomas Moore stated the facility does not have sufficient operating funds and is currently \$300K in debt but that the facility started operating the day before the board meeting under contract with Cypress Water Services to operate the facility. Jennifer Epp, Central Coast Water Board staff, clarified that Big Basin Water Company does not have a signed contract with Cypress Water Services and that Cypress Water Services had not yet been to the facility.

Big Basin Woods Subdivision property owners provided public comments in support of the proposed resolution, but said they need an immediate solution so they can occupy their homes as they get rebuilt. Two property owners said they need to move into their homes within the next one to two months or be at risk of being homeless and losing financing.

Board members asked Central Coast Water Board staff what conditions would need to be met to allow additional property owners to occupy their homes and send wastewater to the facility. Central Coast Water Board staff clarified that the cleanup and abatement order specifies the conditions that would allow the Executive Officer to approve Big Basin Water Company to accept additional wastewater. Executive Officer Keeling clarified the cleanup and abatement order is issued to Thomas Moore and Big Basin Water Company, so Central Coast Water Board staff would need to coordinate with Santa Cruz County staff regarding the issuance of occupancy permits when the wastewater treatment facility can accept additional flows.

# **Discussion/Informational Items**

 Elkhorn Slough National Estuarine Research Reserve Programs Update [Shanta Keeling, Water Resource Control Engineer, 805/549-3464, <u>Shanta.Keeling@waterboards.ca.gov</u>; Mary Hamilton, Environmental Program Manager, 805/542-4768, <u>Mary.Hamilton@waterboards.ca.gov</u>]

Mr. Keeling introduced the item. Rikke Jeppesen and John Haskins with the Elkhorn Slough National Estuarine Research Reserve (ESNERR) presented information on water quality trends based on 30 years of monitoring data, the Elkhorn Slough webbased water quality report card, and restoration projects in the watershed. They also discussed how their work relates to the TMDL Project under development that will address nutrient loading and biostimulatory response conditions. Board members engaged with the speakers regarding several topics including the following: the effects of historic drought and recent atmospheric river events; how restoration efforts are building climate change resiliency in the watershed; and big picture solutions needed for the watershed such as removal of tidal control structures,

increasing natural land buffers to allow for migrating of marsh habitats as sea level continues to rise, and additional nutrient management and control. Margie Kay, a longtime water quality monitoring volunteer, spoke about various aspects of the ESNERR work and Elkhorn Slough Reserve.

Mr. Keeling introduced the item. Mark Davis, Central Coast Water Board Engineering Geologist, presented a comprehensive overview of the Active Oilfield Program, including the history of oil and gas production in the Central Coast Region, oil field locations, staff workflow (underground injection control projects, aquifer exemption reviews, and waste pile management facility oversight), and applicable policies and regulatory tools. Board members asked staff questions related to abandoned wells in the surf zone along the Santa Barbara County coastline, senate bill 1137 health exclusion zone requirements and water quality sampling associated with the legislation, well stimulation within the Central Coast Region, and current bonding requirements for oil wells and proposed bonding requirements for oil wells associated with assembly bill 1167. Janice Zinky, Groundwater Monitoring Section Manager at the State Water Board, and John Iverson, Senior Oil & Gas Engineer at the California Geologic Energy Management Division (CalGEM), also participated in the discussion.

9. California Department of Food and Agriculture (CDFA) Healthy Soils Program [Mary Hamilton, Environmental Program Manager, 805/542-4768, <u>Mary Hamilton@waterboards.ca.gov</u>]

Mr. Keeling introduced the item. Dr. Ravneet Behla of the California Department of Food and Agriculture (CDFA) presented on the CDFA's implementation of the Healthy Soils Program and State Water Efficiency & Enhancement Program since 2017 and grants awarded in the Central Coast Region. Dr. Behla also discussed CDFA's pilot block grant program which started accepting applications this April. Board members engaged with Dr. Behla regarding the carbon sequestration benefits of projects, specific types of projects funded and types of compost used, and the benefits of funding opportunities for purchasing shared equipment.

10. Update - Freshwater and Estuarine Harmful Algal Bloom Program [Melissa Daugherty, Senior Environmental Scientist, 805/542-4643, <u>Melissa.Daugherty@waterboards.ca.gov</u> and Angela Schroeter, Supervising

Mr. Keeling introduced the item. Melissa Daugherty, Central Coast Water Board Senior Environmental Scientist – Specialist, and Carly Nilsen, State Water Board Senior Environmental Scientist - Specialist, presented a comprehensive overview of the Freshwater Harmful Algal Bloom (FHAB) Program, including the environmental conditions that cause freshwater harmful algal blooms and the associated threats to public health, the legislative requirements for monitoring and reporting, coordination with local agencies to share data and recommend health advisories, and how information is shared with the public. Melissa Daugherty also provided a summary of FHAB results for the Central Coast Region. Board members asked staff questions related to public outreach and how outreach materials are designed and developed to communicate the appropriate level of urgency. Board Members also discussed that the lack of resources available to implement the FHAB Program at the Central Coast Region is inappropriate given the threat to public health and associated legislative mandates.

Mr. Keeling introduced the item. Jackie McCloud of the City of Watsonville presented an update on Harmful Algal Bloom management and Total Maximum Daily Load (TMDL) implementation at Pinto Lake. She also discussed recent phosphorus levels in Pinto Lake in the context of the 2017 alum treatment, cyanobacteria monitoring data collected in coordination with UC Santa Cruz, next steps for management practices in the watershed, and ongoing coordination with the California Cyanobacteria and Harmful Algal Bloom (CCHAB) Network. Board members engaged with Ms. McCloud regarding nutrient management on the disc golf course and other land use categories in the watershed, additional strategies to manage phosphorus loading given the limited life expectancy of the alum and other unanticipated benefits of the alum treatment including decreased turbidity and associated increase in aquatic plant growth.

community after the flooding. Board member Hunter engaged with Mr. Bollinger regarding the SAFER program and associated projects to provide replacement water to disadvantaged communities.
