The State Water Board, Division of Drinking Water, Safe and Affordable Funding for Equity and Resilience Program (SAFER) assesses drinking water systems that fail to meet the goals of the human right to water and maintains a list and map of these systems. Drinking water systems that are on the Failing list are those that are out of compliance or consistently fail to meet drinking water standards. Systems that are assessed for meeting the Failing criteria include Community Water Systems (CWSs) and Non-Community Water Systems (NCWSs) that serve schools and daycares.
