

Wednesday, March 16, 2011

PANEL HEARING Thursday, March 17, 2011 Central Coast Regional Water Board

Wednesday, March 16, 2011

Chairman Young called the meeting of the Central Coast Water Board to order at 2:30 p.m. on Wednesday, March 16, 2011, at the Watsonville City Council Chambers, 275 Main Street, Watsonville, California.

1. Roll Call Executive Officer Roger Briggs

2. Introductions Executive Officer Roger Briggs

Executive Officer Roger Briggs introduced staff and State Board Staff Counsel Frances McChesney. He noted that State Board Staff Liaison Frances Spivey-Weber would not be able to attend the meeting but will attend Thursday's meeting. Mr. Briggs asked parties who wished to speak to complete testimony cards and turn them in. Supplemental sheets that were prepared after the agenda was sent out are as follows: Item 6 and Item 11.

Dr. Jean-Pierre Wolff requested the February 3, 2011 minutes be corrected to reflect that he recused himself from Items 19 and 20; Chair Young agreed and Roger Briggs stated the February minutes would be corrected. The corrected record will also show that John Hayashi recused himself from those items.

4. Report by State Water Resources Control Board Liaison...... Status Report

No report available.

Executive Officer Roger Briggs summarized Item 7 and recommended it remain on consent. Additionally, Mr. Briggs summarized and recommended that Item 10 be added to the uncontested items calendar.

MOTION: Russell Jeffries moved to approve the uncontested items calendar

6. San Paso Truck Stop, 81 Wellsona Road Information/Discussion

Mr. Briggs summarized the staff report and supplemental sheet. In response to a Board Member question, Mr. Briggs confirmed that Water Board staff had received and is reviewing a required work plan. There were no other Board Member questions or comments.

Executive Officer Briggs introduced the item and explained that it was a written report. He said that the report includes discussions of recent expedited payment letters issued by staff, permit language relating to spills, a summary of salts violations at the Pasadera WWTP, and a list of recent violations.

Enforcement Coordinator Harvey Packard reviewed the current status of the expedited payment letters.

Dr. Wolff said that he can help staff determine applicability of national standards, ANSI, for example.

Mr. Hayashi asked if dischargers can excuse violations by saying that conditions were out of their control. Mr. Briggs said that the permits explain what level of protection the facilities must provide. Dr. Wolff added that the permits require protection against 100 year floods, for example.

Ms. McChesney explained that when enforcement actions are brought to the Board, then the Board can get into details and specifics.

Mr. Briggs referred to staff outreach with Salinas Valley Cattlemen's Association regarding Total Maximum Daily Load implementation. He discussed budget status and that the Central Coast Region is still being carried in terms of staffing by other water board organizations that have vacancies.

Mr. Briggs discussed groundwater contamination from nitrate, as well as salt buildup in general. However, nitrate is a much more severe health threat. There is a hole in the regulatory framework that means wells with less than five connections have no on-going testing requirements and yet we have data indicating extensive areas with nitrate contamination. Mr. Briggs discussed follow-up with the letter from the Water Board to all county public health officers, and staff efforts toward providing notification to those who are in these areas and have wells that are at risk. Staff is coordinating with State Board domestic water well sampling about to get underway in Monterey County. Board Members discussed the need for counties to include well testing in their ordinances, as well as potential for obtaining well information from tax assessor information and possibly Multiple Listings Service.

Mr. Briggs mentioned the statewide Accomplishments Report and the Water Quality Coordinating Committee meeting September 26 and 27 in Sacramento.

Mr. Hayashi noted that he is recusing himself from the agricultural item on the agenda for the next day, March 17th. Chairman Young adjourned the public meeting at 3:35 p.m. to go to closed session.

Chairman Young called the meeting of the Central Coast Water Board to order at 8:15 a.m. on Thursday, March 17, 2011, at the Watsonville City Council Chambers, 275 Main Street, Watsonville, California.

13. Introductions Executive Officer Roger Briggs

Executive Officer Roger Briggs introduced State Board Staff Counsel Frances McChesney, State Board Staff Liaison Fran Spivey Weber, San Francisco Bay Regional Board Chairman John Muller, and staff. Mr. Briggs asked parties who wished to speak to complete testimony cards and turn them in. Chairman Young instructed that for the purposes of budgeting time, testimony cards must be submitted by 12:00 noon.

14. Conditional Waiver of Waste Discharge Requirements for Discharges from Irrigated Lands

Draft Order No. R3-2011-0006 Panel Hearing

The Central Coast Water Board held Executive Officer Roger Briggs introduced Item 14 as a panel hearing to consider the staff recommendation for an updated Conditional Waiver of Waste Discharge Requirements for Discharges from Irrigated Lands (Draft Agricultural Order). Water Board attorney Frances McChesney stated that Board Members John Hayashi and Jean-Pierre Wolff were recused from this item.

The Water Board heard a staff presentation and many hours of comments on the recommended Draft Agricultural Order. Chairman Young noted that the Board would not be able to conclude this item today and that the hearing would be continued to a San Luis Obispo meeting. Chairman Young provided an opportunity for anyone at the March meeting to come to the podium and address the Board if they would not be able to attend the next meeting in San Luis Obispo. Individuals who provided verbal comments are included in Table 1.

The Water Board continued the hearing to allow all members of the public who came to the meeting an opportunity to present their verbal comments. The hearing was continued to the next Water Board meeting on Wednesday, May 4, 2011, beginning at 10:00 a.m. in San Luis Obispo. Chairman Young stated that members of the public who submitted testimony cards in Watsonville on March 17th, indicating their intent to provide verbal comments at the March 17 Board Meeting, but who did not address the Board, will be able to provide their verbal comments at the May 4, 2011 Board meeting in San Luis Obispo.
