7. Recycled Water Production and Use in the Central Coast Region [Harvey Packard, 805/542-4639, Harvey.packard@waterboards.ca.gov]

Section Manager Harvey Packard reviewed the staff report and made a brief presentation on recycling in the Region. David Buckingham, Morro Bay City Manager, then addressed the Board regarding the City's process to build a new wastewater treatment plant. Mr. Buckingham reported that the city council will likely delay recycling processes to the future. Board members questioned Mr. Buckingham about that decision and other potential options. Mr. Buckingham encouraged the Water Board to participate in the city's decision-making process. State Water Board member Steven Moore briefly discussed the planned update to the State Water Board's Recycled Water Policy and improving data collected for recycled water.

9. City of Santa Barbara Presentation - Subsurface Intake Technologies and Potable Reuse Feasibility Studies

Joshua Haggmark and Rebecca Bjork of City of Santa Barbara public works gave an overview presentation of the City's efforts to start the desalination facility. Thomas F. Seacord and Eric Cherasia (Carollo Engineers, Inc.) presented an overview of the subsurface intake technologies and potable reuse feasibility studies that were performed as required by the 2015 NPDES permit amendment. The presentations described the evaluation of six subsurface intake technologies at three separate beach sites and a variety of direct and indirect potable reuse alternatives.

Kira Redmond of Santa Barbara Channel Keeper commented that since the drought is over that the City should reevaluate its desalination options and look further into recycling. Board members Delgado, Wolff, and Hunter asked the City questions regarding the studies, capacities of the various alternatives and future plans that the City intends to implement. Board member Michael Johnston commented that the process and studies were well done and provide useful information.

His comments to the board included the following:

- 1. The District has completed all its obligations under the Settlement Order: Payment to State Board, Payment to the Bay Foundation for the two Supplemental Environmental Projects; and Completion of our Enhanced Compliance Project... our Grit Removal System, now operational since January.
- Approval on late Wednesday afternoon by the Coastal Commission of a Coastal Development Permit for our Secondary Process Redundancy Project, and past/present projects at our facility. The Commission Approval was for 30 year vs. 10 years as was being recommended by Coastal staff.

John Robertson and Cris Carrigan made a joint presentation to the Board regarding the terms of the April 2017 settlement agreement with the Salinas Basin Agricultural

Stewardship Group, which enables farmers and landowners who are members of the Stewardship Group to avoid enforcement for a specific period of time in exchange for the provision of interim replacement drinking water to those reliant on small water systems and domestic wells in the Salinas Valley that currently have unsafe drinking water due to groundwater nitrate pollution. Board Members voiced support for the settlement agreement and requested that staff provide routine updates to the Board. Board members also made suggestions to maximize public outreach to potential recipients of replacement drinking water.

- 16. Agricultural Order 3.0 Cooperative Groundwater Monitoring Program Status Update [Angela Schroeter, 805/542-4644, Angela.Schroeter@waterboards.ca.gov]

Section Manager Angela Schroeter made a brief presentation to the Board describing the two approved cooperative groundwater-monitoring programs: the Central Coast Groundwater Coalition (CCGC) and the Santa Rosa Creek Valley Groundwater Cooperative. Following a 30-day public notice of the Executive Officer's approvals, which provided the opportunity for interested parties to seek review by the Board, the Board did not receive any requests from interested parties. Randy Sharer, CCGC board member, provided comments to the Board on this item, summarizing recent activities of the CCGC to implement the groundwater monitoring and reporting requirements and to provide assistance to CCGC members to comply with total nitrogen applied reporting requirements.
