State Board Vice Chair D'Adamo provided an overview of a number of statewide issues including: the use of homelessness related data and metrics to inform statewide efforts and coordination; Safe and Affordable Funding for Equity and Resilience (SAFER) program advisory committee and associated efforts; Governor Newsom's Executive Order regarding water shutoffs, Water Quality Coordinating Committee meeting; Water Boards' Racial Equity initiative, State Water Board precedential MS4 Order; annual performance report; State Water Board approved Toxicity Provisions; release of proposed statewide General Winery Order; hexavalent chrome MCL, workshops; release of preliminary draft Construction General Stormwater Order; water loss standards; emergency response lessons learned workshops; etc. Members Gray, Young and Chair Wolff commented on or otherwise inquired about homelessness, the toxicity provisions, and the need for improved Water Board information and technology functionality, respectively.

## **Discussion/Informational Items**

13. Grants Program Update [Katie McNeill, 805/549-3336, Katie.McNeill@waterboards.ca.gov]

Grants Program Manager Katie McNeill presented an overview of funding criteria, internal regulatory program coordination, and highlights of several successful projects and recent awards.

Board members discussed the importance of the grant projects related to the following: fostering good relationships with local agencies and regulated entities; engaging the community in conservation science; leveraging financial resources; addressing climate change impacts associated with wildfires, extreme drought, and sea level rise; and demonstrating water quality outcomes so projects can be duplicated. Ms. McNeill responded to Board members' questions about grants related to post-fire recovery, irrigated agriculture, and fish habitat.

Board members asked questions and engaged in dialogue about disseminating grant project information to the public, such as the timely publicizing of project-specific outcomes, funding awards, and events aimed at specific geographic areas. Mr. Keeling and Ms. McNeill answered questions. Mr. Keeling will follow up with the State Board's Office of Public Affairs about State Board's issuing press releases on behalf of the Central Coast region.

14. Wildfire Prevention and Recovery Activities Update [Mike Sandecki, 805/549-3372, Michael.Sandecki@waterboards.ca.gov]

Water Board staff provided this information item concerning evolving activities in wildfire prevention, emergency response, and post-fire recovery. Board members asked about fuel reduction methods used in the region, including herbivory and prescribed burning, and discussed carbon emissions and sequestration related to wildfire and vegetation management. Staff described the unpredictable nature of wildfire occurrence and the need to shift priorities from core program activities to focus on emergency response and post-fire recovery. No public comment.

# **Enforcement**

Thea Tryon provided a brief overview of the enforcement actions taken between May 1, 2020, through September 30, 2020. Ms. Tryon highlighted that many enforcement actions were still issued despite Covid-19 restrictions. Ms. Tryon explained CalEPA and the Water Boards' have taken the position that it continues to

be important to address non-compliance issues during Covid-19. She also highlighted that inspections are more involved now due to social distance and disinfection requirements. Ms. Tryon briefly summarized status of the enforcement actions described in tables 1 and 2 and explained that a more detailed status update on the Monterey Mushrooms supplemental environmental project is forthcoming at a future Board meeting.
