# Waste Discharge Requirements

13. Consideration of Proposed Order No. R3-2020-0001, General Waste Discharge Requirements for Active Class III Landfills in the Central Coast Region [Ryan Lodge, 805/549-3506, Ryan.Lodge@waterboards.ca.gov and Martin Fletcher, 805/549-3694, Martin.Fletcher@waterboards.ca.gov]

Water Board staff provided an overview of the proposed general order and discussed the landfill program activities regulated, regulatory improvements compared to previous individual waste discharge requirements, the public outreach process, and comments received from interested parties.

The Board had questions regarding landfill gas, landfill lifespans, and closed landfills. The Board also discussed staff outreach to disadvantaged communities. The Board and staff also discussed climate change, disposal of debris from disasters, and landfill flood protection.

14. Consideration of Proposed Order No. R3-2020-0020, General Waste Discharge Requirements for Discharges from Domestic Wastewater Systems with Flows Greater than 100,000 Gallons Per Day.

Staff summarized the staff report, including public comment, consistent effluent limitations, requirements for all wastewater systems to discharge treated wastewater protective of water quality, and requirements for monitoring to confirm protection of water quality.

The Board and staff discussed the need for additional time for wastewater systems to achieve compliance with the requirements of the general permit, specific requirements for backup systems at the wastewater treatment plants, cost impacts to upgrade or modify existing wastewater systems, and funding opportunities for disadvantaged communities.

#### **Public comment:**

 Nicholas DeBar, Director of Public Works/City Engineer, City of Atascadero, had some questions regarding specific effluent standards in Tables 6 and 7 of the general permit. Ms. Epp indicated that compliance with effluent limitations in Tables 6 and 7 are optional with respect to alternative compliance with receiving groundwater quality objectives.

15. Consideration of Proposed Resolution No. R3-2020-0024, Local Agency Management Program for San Luis Obispo County for Implementation of the State Onsite Wastewater Treatment System Policy.

Staff engineer Jon Rokke reviewed the staff report. The LAMP establishes siting, design, operation, and maintenance criteria for onsite wastewater systems and identifies 20 focus areas within the County where nitrogen pollution is projected to either exceed or come close to the maximum contaminant limit for nitrate nitrogen at community build out. The LAMP requires enhanced treatment for new construction and major repair of OWTS in these focus areas going forward.

Board members asked general questions about the LAMP, which were answered by Jon Rokke and Cheryl Journey, San Luis Obispo County chief building official.
