- 5. Report by State Water Resources Control Board Liaison [Sean Maguire, 916/341-5877]

Mr. Maguire introduced himself. He spoke of unprecedented challenges and the positive outgrowths over this year past year. In particular, he discussed the Water Board's emergency water rights curtailment regulations and other actions in response to unprecedented drought conditions; state budget surplus, forthcoming federally funded arrearage payment program to provide relief to community water and wastewater systems for unpaid bills related to the COVID-19 pandemic, and wastewater and drinking water infrastructure funding, and; statewide larger habitat general order development process.

He then took questions from the Board regarding the following issues: the need for new weather forecasting models and public messaging; virtual platform and IT support at the regional level to better facilitate public outreach and education; dam removal projects conflict between storage and ecosystem function; groundwater overdraft and seawater intrusion; drought task force approach shift from reactive to forward thinking; pending in-stream flow studies to better support water supply management; and, legacy appropriative water rights application backlog.

Discussion/Informational Items

7. Statewide General Order for Wineries [Monique Gaido, 805/549-3150, Monique.gaido@waterboards.ca.gov]

Matthew Keeling introduced the item, explaining that it was intended as an information item. Mr. Keeling introduced the following State Board staff:

Scott Couch, supervising geologist, Division of Water Quality Laurel Warddrip, senior geologist, Division of Water Quality Rebeca Griner, environmental scientist, Division of Water Quality

Mr. Couch and Ms. Warddrip provided a summary of the general permit, which is designed to achieve statewide consistency, streamline permitting, and allow staff to focus on regulatory compliance.

Board members had several comments and questions regarding the transition timeline, annual fees, nitrogen effluent limits, land application practices, guidance for salt control plans, regulation of wineries within wastewater service areas, and sustainability programs. Ms. Warddrip and Mr. Couch responded to the questions and comments. Chair Wolff thanked State Board staff and complimented them on the valuable information.

8. Integrated Report Update [Shanta Keeling, 805/549-3464, Shanta Keeling@waterboards.ca.gov and Mary Hamilton, 805/542-4768, Mary.Hamilton@waterboards.ca.gov]

Item 8 was an informational item to provide the Central Coast Water Board an update on the status of California's Integrated Report for the 2020-2022 cycle as it relates to the Central Coast Region. Central Coast Water Board staff engineer

Shanta Keeling presented on the legal requirements for completing the Integrated Report, the process, timeline, results, and public comments.

Board member Hunter inquired about when staff started using data from all data sources, other than statewide collected data. She also inquired as to when we began requiring data considered for the Integrated Report to be submitted in a certain format via CEDEN (California Environmental Data Exchange Network). Section Manager Mary Hamilton responded that we had always included some data of various formats in past cycles. Starting with the 2014-2016 cycle, the CEDEN requirement was more heavily relied upon. Dr. Hunter stated that she was glad to see more data is being included by various groups.

Board member Mr. Mike Johnston inquired about how we can take waterbody/pollutant combinations off the 303(d) List, specifically Beach Road ditch, as this is mainly a tile drain receiving conveyance. Mary Hamilton responded that because Beach Road ditch is a designated water of the state and has the beneficial uses of municipal supply, recreational contact, and aquatic habitat, the Board would need to perform a use attainability analysis to determine what beneficial uses are appropriate for this waterbody and reanalyze the data. Central Coast Water Board staff could also collect more data and show that the data do not indicate an impairment to remove waterbody/pollutant combinations from the 303(d) List. Mr. Johnston would like to see a bioreactor project in this area.

 - Tyler Sullivan, California Coastkeeper Alliance acknowledged and thanked staff and stakeholders for Ag Order 4.0 "roll-out" efforts and discussed the Department of Water Resources recent approval of the Groundwater Sustainability Plan for the Salinas Valley 180/400 aquifer and direction to take a different approach to addressing water quality through broader interagency coordination.

10. Consideration of Settlement Agreement and Stipulation for Entry of Administrative Civil Liability Order in the matter of Monterey One Water; Unauthorized Discharges of Untreated Wastewater in 2017, 2018, and 2019 (Proposed Order No. R3-2021-0051)

Matthew Keeling summarized procedures for the item and introduced the following parties:

Prosecution Team: Thea Tryon (Central Coast Water Board assistant executive officer), Todd Stanley (Central Coast Water Board Enforcement Program staff), Tamara Anderson (Central Coast Water Board enforcement coordinator), Kailyn Ellison (State Water Board, Office of Enforcement), and expert specialists Katya Smirnova (consultant to State Water Board) and Bryan Elder (State Water Board, Office of Enforcement)

Discharger representatives: Paul Sciuto (Monterey One Water), Melissa Thorme (counsel to Monterey One Water)

Mr. Stanley summarized three alleged violations that occurred at Monterey One Water's facilities and the proposed settlement agreement and stipulation for entry of Administrative Civil Liability Order (ACLO) No. R3-2021-0051 to resolve those violations. Mr. Stanley also described the private lateral rehabilitation supplemental environmental project in the Castroville Community Services District's service area included in the proposed settlement agreement. Board members asked questions and the Advisory Team, Prosecution Team, and discharger representatives provided responses. The board engaged with staff and Mr. Sciuto regarding the violations, actions taken and associated costs, and the merits of the proposed supplemental environmental project.

In response to Board member comments, Mr. Keeling recommended a change to Attachment E of the settlement agreement to specify that Monterey One Water will conduct the lateral rehabilitations at low income households to the maximum extent possible. Board members, Advisory Team, Prosecution Team, and discharger representatives all agreed to this change.
