 Consideration of a settlement agreement and stipulation for entry of an administrative civil liability order in the matter of California Department of Corrections and Rehabilitation, California Men's Colony; unauthorized discharges of waste and effluent limitation violations.

Minutes:

Thea Tryon, Assistant Executive Officer, introduced the item.

Prosecution Team members Tamara Anderson, Technical Senior Water Resource Engineer and Enforcement Coordinator, and Paul Ciccarelli, Office of Enforcement, presented the facts of the case and the recommendation to adopt Settlement Agreement and Stipulation for Entry of Administrative Civil Liability Order R3-2025-0005.

Staff engaged with the Board members regarding actions the facility is taking to correct repeated violations and asked to hear from the facility staff regarding specific actions taken or planned to prevent this from happening again. Vice Chair Wolff expressed concern that there appears to be no evidence of changes in behavior at the facility and that paying repeated fines does not result in improvements at the facility and environmental protection. Vice Chair Wolff expressed the need for funding allocated to projects (via Supplemental Environmental Projects) to have a direct benefit to the local environment and address the direct harm done to the creek and downstream estuary and beaches.

Chair Gray mentioned opportunities for inmate internship and asked for more clarity on actions to staff the plant operations. Member Hoskins expressed concern for discharge violations having impacts to the environment and public health.

Sophie Froelich, Office of Chief Council, advised the Board members on their options for this item including approve, approve with changes, reject the settlement, or reject with high level instructions to staff such as asking to hear the evidence in a civil liability complaint brought before the Board and noted that this action would not allow the Board to require specific actions at the facility.

Thea Tryon clarified that bringing in USEPA was strategic because they have additional tools to compel compliance, and they were brought in to address these serious violations. If improvements are not made, USEPA can take additional actions.

Warden Samules explained CDCR's commitment to stop violations and work with Water Boards and USEPA.
