NOTICE OF WORKSHOP ON THE CENTRAL COAST WATER BOARD'S PERMITTING PROCESS FOR DIABLO CANYON POWER PLANT

October 31, 2025

NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board, Central Coast Region (Central Coast Water Board) will hold a public workshop to discuss the Central Coast Water Board's permitting process as it relates to the upcoming release of a tentative National Pollutant Discharge Elimination System (NPDES) permit and a tentative Clean Water Act section 401 water quality certification for Pacific Gas and Electric Company's Diablo Canyon Power Plant.

The workshop will offer an opportunity for interested persons and agencies to receive information and provide public comment on the tentative NPDES permit and 401 certification. Prior to the workshop, the Central Coast Water Board will issue the tentative NPDES permit and the tentative certification for public review and comment.

A quorum of the Central Coast Water Board may be present at the workshop, and the Board may provide general feedback to staff; however, the Board will not take any formal action.

The workshop will include both a physical meeting location and an option to participate remotely as described below.

The workshop will include Central Coast Water Board staff presentations about the tentative permit, tentative certification, and permitting process; an opportunity for the public to ask questions; and an opportunity for public comment.

The workshop will be recorded, and the recording will be part of the administrative record for this matter. Staff will review all comments and consider them in developing the tentative NPDES permit and the 401 certification.
