¹ As of 01/29/2016 sixty one (61) wells have been sampled for the Buckley Road Area TCE Investigation; however, two (2) samples are pending laboratory results, therefore fifty nine (59) well samples have laboratory results submitted.

² **TCE** = Trichloroethene (aka trichloroethylene)

³ MCL = Maximum Contaminant Level (the MCL for TCE is 5.0 micrograms per liter [µg/L])
