RESOLUTION NO. R3-2020-0024

APPROVING THE LOCAL AGENCY MANAGEMENT PROGRAM FOR SAN LUIS OBISPO COUNTY DEPARTMENT OF PLANNING AND BUILDING

The Central Coast Regional Water Quality Control Board (Central Coast Water Board) finds:

- 1. On June 19, 2012, the State Water Resources Control Board (State Water Board) adopted Resolution No. 2012-0032, which in part, adopts the *Water Quality Control Policy for Siting, Design, Operation, and Maintenance of Onsite Wastewater Treatment Systems* (OWTS Policy).
- 2. The OWTS Policy allows a local agency to propose a Local Agency Management Program (LAMP) to the Central Coast Water Board for approval.
- 3. On June 21, 2016, the San Luis Obispo County Board of Supervisors authorized the Chief Building Official to submit a letter to the Central Coast Water Board informing them of the County's intent to develop a LAMP.
- 4. The first draft of the San Luis Obispo County LAMP was submitted in August 2016.
- 5. San Luis Obispo County held two Technical Advisory Committee meetings in 2016, and conducted two public meetings where they answered questions and received comments about the proposed LAMP from stakeholders.
- San Luis Obispo County and Central Coast Water Board staff worked collaboratively in the development of the LAMP and Central Coast Water Board staff have determined that the LAMP addresses the required elements of the OWTS Policy.
- 7. The LAMP also requires the County to develop Advanced Protection Management Plans for waterbodies degraded by onsite wastewater treatment systems (OWTS).
- 8. On June 4, 2020, the Central Coast Water Board notified interested persons of the availability of the draft LAMP, the Central Coast Water Board's intent to approve the LAMP and provided interested persons with an opportunity to submit comments and recommendations.

9. On September 25, 2020, the Central Coast Water Board, in a noticed public meeting, heard and considered all comments pertaining to this action.

THEREFORE, be it resolved:

- 1. The Central Coast Water Board hereby approves the County of San Luis Obispo LAMP submitted by them;
- The Central Coast Water Board directs that the County of San Luis Obispo may implement onsite wastewater treatment system programs pursuant to its LAMP within its local jurisdiction; and
- The Central Coast Water Board further directs its Executive Officer to act on its behalf to process for review, comment, and provide approval of future modifications to the LAMP submitted by the County of San Luis Obispo.
