NOTICE OF APPLICABILITY; GENERAL 401 WATER QUALITY CERTIFICATION ORDER REQUIREMENTS FOR THE CALIFORNIA DEPARTMENT OF PARKS AND RECREATION, LAKE CLEMENTINE BOAT RAMP REPAIR PROJECT (WDID#5A31CR00395), PLACER COUNTY

On 14 September 2014, the California Department of Parks and Recreation (Applicant) filed a notification requesting coverage under the 19 April 2012 State Water Resources Control Board Clean Water Act Section 401 Water Quality Certification of United States Army Corps of Engineers 2012 Nationwide Permits (General Certification Order). After review of the notification and the supplemental material submitted by the Applicant, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) has determined that the project qualifies for enrollment under this General Certification Order. The proposed activity will take place within less than 0.05 acre of waters of the United States.

The Central Valley Water Board is certifying this project under United States Army Corps of Engineers Nationwide Permit #36, Boat Ramps, subject to the conditions and the notification requirements described in the Nationwide Permit ("Special Conditions"). This Notice of Applicability is being issued under the General Certification Order pursuant to § 3838 of the California Code of Regulations.

The project must proceed in accordance with the requirements contained in this Notice of Applicability and General Certification Order. Coverage under the General Certification Order is no longer valid if the project (as described) is modified.

PROJECT DESCRIPTION:

The Lake Clementine Boat Ramp Repair Project (Project) consists of installing a 13-foot extension to the existing boat ramp at Lake Clementine. The extension is a 13-foot long and 30-foot wide ARMORFLEX ramp. Approximately 39 cubic yards of existing silt and rip rap will be dredged from the lake to accommodate installation. The lake water level will be lowered in consultation with the United States Army Corps of Engineers, National Oceanic and Atmospheric Administration, and United States Fish and Wildlife Service in order to dewater the Project area. If in-water work is unavoidable, the Applicant will install a turbidity curtain and implement Best Management Practices for the duration of construction activities.
