**NOTICE OF APPLICABILITY; UNITED STATES ARMY CORPS OF ENGINEERS, REGIONAL GENERAL PERMIT 14 FOR PLACER VINEYARDS SPECIFIC PLAN INFRASTRUCTURE, PLACER VINEYARDS CENTRAL GROUP, LLC, CENTRAL/1A SHARED BASELINE ROAD #01 PROJECT (INFRASTRUCTURE SEGMENT G) (WDID NO. 5A31CR00404-001), PLACER COUNTY**

On 2 August 2018, Placer Vineyards Development Group, LLC (Applicant) filed a Notice of Intent (NOI) requesting coverage under the 30 May 2018 Regional Water Quality Control Board's Amended Clean Water Act Section 401 Technically Conditioned Water Quality Certification, Regional General Permit 14 for Placer Vineyards Specific Plan Infrastructure Project (Programmatic Certification) issued to the United States Army Corps of Engineers (WDID No. 5A31CR00404A1). A request for a name change from Placer Vineyards Development Group, LLC to Placer Vineyards Central Group, LLC was submitted 6 February 2019. After review of the NOI and the supplemental material submitted by the Applicant, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) has determined that the Placer Vineyards Central/1A Shared Baseline Road #01 Project (Infrastructure Segment G) (Project) qualifies for enrollment under this Programmatic Certification. The proposed activity will take place within approximately 0.838 acre of waters of the United States.

The Central Valley Water Board is certifying this Project under Programmatic Certification WDID No. 5A31CR00404A1, subject to the conditions and the notification requirements described in the Programmatic Certification. This Notice of Applicability (NOA) is being issued at the request of Placer Vineyards Central Group, LLC (hereinafter Enrollee) under the Programmatic Certification pursuant to Section 3838 of the California Code of Regulations.

The Project must proceed in accordance with the requirements contained in this NOA and the Programmatic Certification. The Project is described in the NOI Form requesting coverage under the Programmatic Certification, dated 31 July 2018, and supplementary information (Application Package). If the Project is modified from that described in the Application Package, then coverage under the Programmatic Certification is no longer valid.

## **I. Project Description**

The Project includes the installation of a water line proposed to be installed to the south of the existing Baseline Road within the 14.77-acre Project boundary of Infrastructure Segment G. The infrastructure elements of this Project will include on- and offsite infrastructure elements required for the development of the Placer Vineyards Specific Plan, specifically roadway improvements along Baseline Road and a temporary easement area within a portion of Placer Vineyards Property 1A.

The water line will consist of a 24-inch ductile iron pipe, which will tee into the existing 16-inch transmission main at Walerga/Fiddymont Road. To install the water line, an open trench will be dug (both in the upland areas and through aquatic features where the line is proposed to be installed), the water line will be placed, and the dirt excavated to dig the open trench will be used to backfill the trench and bury the water line. The Project also includes the expansion of Baseline Road, which will include the fill of wetlands on site, grading, culvert replacement, and laying down asphalt.

## **II. Project Location**

Address: Baseline Road, 1.3 miles west of Walerga/Fiddymont Road in Placer County, CA.

County: Placer County

## **III. Project Impact and Receiving Waters Information**

The Project is located within the jurisdiction of the Central Valley Water Board. Receiving waters and groundwater potentially impacted by this Project are protected in accordance with the Water Quality Control Plan for the Sacramento River and San Joaquin River Basins, Fifth Edition, May 2018 (Basin Plan). The plan for the region and other plans and policies may be accessed online at: [http://www.waterboards.ca.gov/plans\\_policies/](http://www.waterboards.ca.gov/plans_policies/). The Basin Plan includes water quality standards, which consist of existing and potential beneficial uses of waters of the state, water quality objectives to protect those uses, and the state and federal antidegradation policies.

It is the policy of the State of California that every human being has the right to safe, clean, affordable, and accessible water adequate for human consumption, cooking, and sanitary purposes. This NOA promotes that policy by requiring discharges to meet maximum contaminant levels designed to protect human health and ensure that water is safe for domestic use.

Project impact and receiving waters information can be found in Attachment B. Table 1 of Attachment B shows the receiving waters and beneficial uses of waters of the state impacted by the Project. Individual impact location and quality is shown in Table 2 of Attachment B.

**IV. Description of Direct Impacts to Waters of the United States**

Total Project fill/excavation quantities for all impacts are summarized in Table 1. Permanent impacts are categorized as those resulting in a physical loss of area and those degrading ecological conditions.

**V. Fees Received**

An application fee of \$1,500.00 was received on 19 March 2018. A partial project fee balance of \$9,619.00 was received on 19 October 2018. The remaining project fee balance of \$212.00 was received on 5 November 2018. The fee amount was determined as required by California Code of Regulations, Title 23, sections 3833(b)(3) and 2200(a)(3) and was calculated as Category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.

**VI. Conditions**

The Central Valley Water Board has independently reviewed the record of the Project to analyze impacts to water quality and designated beneficial uses within the watershed of the Project. In accordance with this NOA, the Enrollee may proceed with the Project under the following terms and conditions:

**A. Authorization**

Impacts to waters of the state shall not exceed quantities shown in Table 1.

**B. Reporting and Notification Requirements**

The following section details the reporting and notification types and timing of submittals. Requirements for the content of these reporting and notification types are detailed in Attachment C, including specifications for photo and map documentation during the

Project. Written reports and notifications must be submitted using the Reporting and Notification Cover Sheet located in Attachment C, which must be signed by the Enrollee or an authorized representative.

The Enrollee must submit all notifications, submissions, materials, data, correspondence, and reports in a searchable Portable Document Format (PDF). Documents less than 50 MB must be emailed to: [centralvalleyredding@waterboards.ca.gov](mailto:centralvalleyredding@waterboards.ca.gov).

In the subject line of the email, include the Central Valley Water Board Contact, Project name, and WDID. Documents that are 50 MB or larger must be transferred to a disk and mailed to the Central Valley Water Board Contact.

## 1. Project Reporting

- a. **Monthly Reporting** – The Enrollee must submit a Monthly Report to the Central Valley Water Board on the 1st day of each month beginning the month after the effective date of this NOA. Monthly reporting shall continue until the Central Valley Water Board issues a Notice of Project Complete Letter to the Enrollee.
- b. **Annual Reporting** – The Enrollee shall submit an Annual Report each year on the 1st day of the month one year after the effective date of the NOA. Annual reporting shall continue until a Notice of Project Complete Letter is issued to the Enrollee.

## 2. Project Status Notifications

- a. **Commencement of Construction:** The Enrollee shall submit a Commencement of Construction Report at least seven (7) days prior to start of initial ground disturbance activities and corresponding Waste Discharge Identification Number (WDID No.) issued under the NPDES General Permit for Storm Water Discharges Associated with Construction and Land Disturbance Activities (Order No. 2009-0009-DWQ; NPDES No. CAS000002).

## 3. Conditional Notifications and Reports: The following notifications and reports are required as appropriate.

### a. Accidental Discharges of Hazardous Materials<sup>3</sup>

Following an accidental discharge of a reportable quantity of a hazardous material, sewage, or an unknown material, the following applies (Water Code, Section 13271):

- i. As soon as (A) Enrollee has knowledge of the discharge or noncompliance, (B) notification is possible, and (C) notification can be provided without substantially impeding cleanup or other emergency measures then:
  - first call – 911 (to notify local response agency)
  - then call – Office of Emergency Services (OES) State Warning Center at:(800) 852-7550 or (916) 845-8911

  - ii. Following notification to OES, the Enrollee shall notify Central Valley Water Board, as soon as practicable (ideally within 24 hours). Notification may be delivered via written notice, email, or other verifiable means.
  - iii. Within five (5) working days of notification to the Central Valley Water Board, the Enrollee must submit an Accidental Discharge of Hazardous Material Report.
- b. Violation of Compliance with Water Quality Standards:** The Enrollee shall notify the Central Valley Water Board of any event causing a violation of compliance with water quality standards. Notification may be delivered via written notice, email, or other verifiable means.
- i. This notification must be followed within three (3) working days by submission of a Violation of Compliance with Water Quality Standards Report.
- c. In-Water Work and Diversions:**
- i. The Enrollee shall notify the Central Valley Water Board at least forty-eight (48) hours prior to initiating work in water or stream diversions. Notification may be delivered via written notice, email, or other verifiable means.
  - ii. Within three (3) working days following completion of work in water or stream diversions, an In-Water Work/Diversions Water Quality Monitoring Report must be submitted to Central Valley Water Board staff.
- d. Transfer of Property Ownership:** This NOA is not transferable in its entirety or in part to any person or organization except after notice to the Central Valley Water Board in accordance with the following terms:
- i. The Enrollee must notify the Central Valley Water Board of any change in ownership or interest in ownership of the Project area by submitting a Transfer of Property Ownership Report. The Enrollee and Purchaser must sign and date the notification and provide such notification to the Central Valley Water Board at least 10 days prior to the transfer of ownership. The purchaser must also submit a written request to the Central Valley Water Board to be named as the Enrollee in a revised NOA.
  - ii. Until such time as this NOA has been modified to name the purchaser as the Enrollee, the Enrollee shall continue to be responsible for all requirements set forth in this NOA.
- e. Transfer of Long-Term BMP Maintenance:** If maintenance responsibility for post-construction BMPs is legally transferred, the Enrollee must submit to the Central Valley Water Board a copy of such documentation and must provide the transferee with a copy of a long-term BMP maintenance plan that complies with manufacturer or designer specifications. The Enrollee must provide such notification to the Central Valley Water Board with a Transfer of Long-Term BMP Maintenance Report at least 10 days prior to the transfer of BMP maintenance responsibility.

### C. Water Quality Monitoring

1. Surface water monitoring shall be conducted in accordance with the Programmatic Certification issued to the United States Army Corps of Engineers (WDID No. 5A31CR00404A1).
2. **Accidental Discharges/Noncompliance:** Upon occurrence of an accidental discharge of hazardous materials or a violation of compliance with a water quality standard, Central Valley Water Board staff may require water quality monitoring based on the discharge constituents and/or related water quality objectives and beneficial uses.
3. **Post-Construction:** Visually inspect the Project site during the rainy season for one year to ensure excessive erosion, stream instability, or other water quality pollution is not occurring in or downstream of the Project site. If water quality pollution is occurring, contact the Central Valley Water Board staff member overseeing the Project within three (3) working days. The Central Valley Water Board may require the submission of a Violation of Compliance with Water Quality Standards Report. Additional permits may be required to carry out any necessary site remediation.

## VII. Compensatory Mitigation

### A. Compensatory Mitigation for Temporary Impacts

1. The Enrollee shall restore all areas of temporary impacts, including Project site upland area, which could result in a discharge to waters of the state to pre-construction contours and conditions upon completion of construction activities.

### B. Compensatory Mitigation for Permanent Impacts<sup>4</sup>

1. **Compensatory Mitigation Plan.** The Enrollee shall provide compensatory mitigation for impacts to waters of the United States and waters of the state in accordance with Clean Water Act Section 404 Mitigation Strategy (Mitigation Strategy) for the Placer Vineyards Specific Plan (PVSP) dated 22 September 2015 and incorporated herein by reference. Any deviations from, or revisions to, the Mitigation Strategy for PVSP must be pre-approved by Central Valley Water Board staff. The monitoring period shall continue until the Central Valley Water Board staff determines that performance standards have been met. This may require the monitoring period to be extended.
2. **Purchase of Mitigation Credits by Enrollee for Compensatory Mitigation**
  - a. A copy of the fully executed agreement for the purchase of mitigation credits shall be provided to the Central Valley Water Board prior to the initiation of in water work.
3. **Total Required Compensatory Mitigation**
  - a. The Enrollee is required to provide compensatory mitigation for the authorized impact to 0.033 acre of Channel (Curry Creek) by purchasing 0.066 Riverine with Riparian credits in the Western Placer County In-Lieu Fee Program. In addition, the Enrollee is required to restore 0.016 acre of both land cover and Waters of the

United States (Curry Creek) to preconstruction conditions upon competition of Baseline Road widening.

- b. The Enrollee is required to provide compensatory mitigation for the authorized impact to 0.002 acre of Ephemeral Drainage by purchasing 0.004 Vernal Pool Complex credits in the Western Placer County In-Lieu Fee Program.
- c. The Enrollee is required to provide compensatory mitigation for the authorized impact to 0.021 acre of Roadside Ditch by purchasing 0.042 Seasonal Wetland credits in the Western Placer County In-Lieu Fee Program.
- d. The Enrollee is required to provide compensatory mitigation for the authorized impact to 0.012 acre of Seasonal Wetlands by purchasing 0.024 Vernal Pool credits in the Western Placer County In-Lieu Fee Program.
- e. The Enrollee is required to provide compensatory mitigation for the authorized impact to 0.001 acre of Seasonal Wetland Swales by purchasing 0.002 Vernal Pool Complex credits in the Western Placer County In-Lieu Fee Program.
- f. The Enrollee is required to provide compensatory mitigation for the authorized impact to 0.871 acre of Vernal Pool by purchasing 1.742 Vernal Pool credits in the Western Placer County In-Lieu Fee Program.
- g. Total required Project compensatory mitigation information for permanent physical loss of area is summarized in Table 2.

- h. The Enrollee is required to provide compensatory mitigation for the authorized indirect impacts to 0.056 acre of Seasonal Wetlands by purchasing 0.112 Vernal Pool credits in the Western Placer County In-Lieu Fee Program.
- i. The Enrollee is required to provide compensatory mitigation for the authorized indirect impacts to 0.117 acre of Seasonal Wetland Swales by purchasing 0.234 Vernal Pool Complex credits in the Western Placer County In-Lieu Fee Program.
- j. The Enrollee is required to provide compensatory mitigation for the authorized indirect impacts to 0.030 acre of Vernal Pool by purchasing 0.060 Vernal Pool credits in the Western Placer County In-Lieu Fee Program.
- k. Total required Project compensatory mitigation information for permanent physical loss of area is summarized in Table 3.





### Definition of Reporting Terms

1. **Active Discharge Period:** The active discharge period begins with the effective date of this NOA and ends on the date that the Enrollee receives a Notice of Completion of Discharges Letter or, if no post-construction monitoring is required, a Notice of Project Complete Letter. The Active Discharge Period includes all elements of the Project including site construction and restoration, and any Enrollee responsible compensatory mitigation construction.
2. **Request for Notice of Completion of Discharges Letter:** This request by the Enrollee to the Central Valley Water Board staff pertains to projects that have post construction monitoring requirements, e.g. if site restoration was required to be monitored for 5 years following construction. Central Valley Water Board staff will review the request and send a Completion of Discharges Letter to the Enrollee upon

approval. This letter will initiate the post-discharge monitoring period and a change in fees from the annual active discharge fee to the annual post-discharge monitoring fee.

3. **Request for Notice of Project Complete Letter:** This request by the Enrollee to the Central Valley Water Board staff pertains to projects that either have completed post-construction monitoring and achieved performance standards or have no post-construction monitoring requirements, and no further Project activities are planned. Central Valley Water Board staff will review the request and send a Project Complete Letter to the Enrollee upon approval. Termination of annual invoicing of fees will correspond with the date of this letter.
4. **Post-Discharge Monitoring Period:** The post-discharge monitoring period begins on the date of the Notice of Completion of Discharges Letter and ends on the date of the Notice of Project Complete Letter issued by the Central Valley Water Board staff. The Post-Discharge Monitoring Period includes continued water quality monitoring or compensatory mitigation monitoring.
5. **Effective Date:** 16 May 2019.
