ORDER AMENDING NOTICE OF APPLICABILITY: STATE WATER RESOURCES CONTROL BOARD WATER QUALITY ORDER NO. 2004-0004-DWQ, BORGE CONSTRUCTION, INC., BORGE - BRUCE ROAD/SR 32 SITE DEVELOPMENT PROJECT (WDID NO. 5A04CR00319A1), BUTTE COUNTY

This Order responds to the 31 August 2021 request for an amendment of the Borge Construction, Inc., Borge – Bruce Road/SR 32 Site Development Project Notice of Applicability (WDID No. 5A04CR00319). The original Notice of Applicability (NOA) was issued on 18 November 2020. The requested amendment is hereby approved, and the original NOA is therefore amended as described below. Please attach this document to the original NOA.

AMENDMENT:

Borge Construction, Inc. is requesting an amendment to the Notice of Applicability to change the required compensatory mitigation from 0.04 acre of vernal pool establishment credits and 0.02-acre vernal pool preservation credits to 0.06-acre vernal pool preservation credits at Meridian Ranch Mitigation Bank. The reason for the request is that no vernal pool establishment credits are currently available at the Meridian Ranch Mitigation Bank. Therefore, Section IX.A.2; Section IX, Table 2; and Attachment B, Table 2 are amended in underline format below.

IX.A Compensatory Mitigation for Permanent impacts:

2. Total Required Compensatory Mitigation

- **a.** The Enrollee is required to provide compensatory mitigation for the authorized impact to 0.018 acre of vernal pool by purchasing <u>0.06 vernal</u> <u>pool preservation credits</u> from Meridian Ranch Mitigation Bank.
- **b.** Total required Project compensatory mitigation information for permanent physical loss of area is summarized in Table 2. [Establishment (Est.), Reestablishment (Re-est.), Rehabilitation (Reh.), Enhancement (Enh.), <u>Preservation (Pres.), Unknown].</u>
