**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; ROBERTS DITCH IRRIGATION
COMPANY, CHANNEL MAINTENANCE DREDGE PROJECT
(WDID#5A06CR00066A1), COLUSA COUNTY**

This Order responds to the 2 February 2023 request for an amendment of the Channel Maintenance Dredge Project (Project) Section 401 Water Quality Certification (WDID#5A06CR00066). The original Water Quality Certification (Certification) was issued on 16 March 2018. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please retain this document with the original Certification for your records.

AMENDMENT:

Roberts Ditch Irrigation Company is requesting a time extension through 20 August 2028 to correspond with the updated expiration date of the US Army Corps of Engineers 404 Permit (SPK-1998-00699). Roberts Ditch Irrigation Company has provided documentation from the United States Army Corps of Engineers authorizing in-water construction activities to continue until 20 August 2028.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$4,246.00 for the original Certification were received on 23 January 2018. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
