### **ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; COUNTY OF GLENN, COUNTY ROAD 67 BRIDGE REPLACEMENT 11C-179A PROJECT (WDID NO. 5A11CR00039A1), GLENN COUNTY**

This Order responds to the 9 February 2024 request for an amendment to the County of Glenn, County Road 67 Bridge Replacement 11C-179a Project Section 401 Water Quality Certification (WDID No. 5A11CR00039). The original Water Quality Certification was issued on 10 July 2019. The requested amendment is hereby approved. The original Certification is therefore amended as described below. The request has been approved and the expiration date of the Section 401 Water Quality Certification is extended to **14 March 2026**.
