**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; CALIFORNIA DEPARTMENT
OF TRANSPORTATION, NAP 128 PM 127.7 SLIPOUT AND PAVEMENT FAILURE
PROJECT (WDID#5A28CR00052A1), NAPA COUNTY**

This Order responds to the 16 June 2025 request for an amendment of the NAP 128 PM 27.7 Slipout and Pavement Failure (EA 04-3X020) Project (Project) Section 401 Water Quality Certification (WDID#5A28CR00052A1). The original Water Quality Certification (Certification) was issued on 28 March 2025. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Caltrans is requesting a change to the Project impacts and time extension through 1 January 2026. The modification will allow Caltrans to proceed with the Project described in the original Certification.

The Project Description of the Certification is amended as shown below:

The 0.063-acre NAP 128 PM 27.7 Slipout and Pavement Failure (EA 04-3X020) Project (Project) consists of the repair of a slipout at the embankment at postmile 27.7 on State Route 128. The repair would require construction of a 50-foot long and 36-foot-deep secant pile wall between the edge of pavement and the embankment failure. Rock slope protection will be placed in front of the pile wall, within Wragg Creek, to reinforce and protect the embankment.

The Project will permanently impact 0.053 acre/223 cubic yards and temporarily impact 0.01 acre of waters of the United States.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$4,212.00 for the original Certification were received on 25 March 2025. The fee amount was determined as

required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category F - Emergency Projects authorized by a Water Board General Order (fee code 85) with the dredge and fill fee calculator.
