ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; CALIFORNIA DEPARTMENT OF TRANSPORTATION, YUBA PASS SOH (SEPARATION OVERHEAD) BRIDGE PROJECT (WDID#5A29CR00140A1), NEVADA AND PLACER COUNTIES

This Order responds to the 7 February 2024 request for an amendment of the Yuba Pass SOH Overhead Bridge Project (Project) Section 401 Water Quality Certification (WDID#5A29CR00140). The original Water Quality Certification (Certification) was issued on 16 October 2023. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

The California Department of Transportation is requesting a change to the mercury monitoring requirements, impacts to waters of the state, and compensatory mitigation. The mercury monitoring requirements are no longer required. There will be no temporary impacts, and compensatory mitigation requirements for temporary impacts are no longer required. Additional permanent impacts and compensatory mitigation for permanent impacts to waters of the state are shown below:
