ORDER AMENDING GENERAL ORDER NO. R5-2020-0049, WASTE DISCHARGE REQUIREMENTS AND CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION OF THE WESTERN PLACER COUNTY HABITAT CONSERVATION PROGRAM/NATURAL COMMUNITY CONSERVATION PLAN PLACER COUNTY WATER AGENCY (PCWA) REGIONAL GENERAL PERMIT 19; UNITED STATES DEPARTMENT OF THE ARMY CORPS OF ENGINEERS, (WDID#5A31CR00538A1), PLACER COUNTY

This Order responds to the 11 June 2025 request for an amendment of General Order R5-2020-0049, Waste Discharge Requirements and Clean Water Act Section 401 Water Quality Certification of the Western Placer County Habitat Conservation Program/Natural Community Conservation Plan (HCP/NCCP) Placer County Water Agency (PCWA) Regional General Permit 19 (WDID#5A31CR00538). The original General Order was issued on 16 October 2020. The requested amendment is hereby approved. The original General Order is therefore amended as described below. Please attach this document to the original General Order.

### AMENDMENT:

The United States Department of the Army, Corps of Engineers (USACE) is requesting a time extension of the general Order to coincide with the reissuance of USACES's Regional Geral Permit 19 (RGP19): Minimal Impact Covered Activities by Placer County Water Agency Under the Habitat Conservation Plan/Natural Community Conservation Plan.

The General Order is amended to be valid for the term authorized under USACE's RGP 19. The General Order is not valid if coverage under RGP 19 has expired or has been terminated by USACE.
