ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; RAINTREE INVESTMENT CORPORATION, FOLSOM 138 PROJECT (WDID#5A34CR00597A1), SACRAMENTO COUNTY

This Order responds to the 13 February 2024 request for an amendment of the Folsom 138 Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00597A1). The original Water Quality Certification (Certification) was issued on 20 August 2014. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Raintree Investment Corporation is requesting a time extension through 16 September 2024. A time extension was authorized by the United States Army Corps of Engineers on 25 October 2019. Raintree Investment Corporation has provided documentation from the United States Army Corps of Engineers (SPK-2008-00326) authorizing in-water construction activities to continue until 16 September 2024.

The Certification is amended to update the Certification expiration to 16 September 2024.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. A total fee of \$1,614.00 for the original Certification was received on 3 January 2014. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
