ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; THE CITY OF ELK GROVE, BOND ROAD UPSIZING PROJECT (WDID#5A34CR00614A1), SACRAMENTO COUNTY

This Order responds to the 16 May 2023 request for an amendment of the Bond Road Upsizing (Project) Section 401 Water Quality Certification (WDID#5A34CR00614). The original Water Quality Certification (Certification) was issued on 8 June 2015. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

The City of Elk Grove is requesting an updated project description. The City of Elk Grove has provided documentation from the United States Army Corps of Engineers (SPK-2015-00135) authorizing in-water construction activities to continue until 1 October 2024.

The proposed headwall now includes a curtain of Class II RSP, increasing the permanent impacts to jurisdictional waters from 0.002 acres to 0.004 acres for Laguna Creek. In addition, the updated design of the headwall will require a temporary water diversion that was not necessary during the submittal of the original permit application. Local dewatering will increase temporary impacts to Laguna Creek from 0.002 acres to 0.010 acres.

The Certification is amended to reflect an updated authorization for in-water construction activities through 1 October 2024. Table 1 in the Certification is amended as shown below:

No fee was required for this amendment. Total fees of \$200.00 for the original Certification were received on 31 December 2014. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
