## ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; K. HOVNANIAN HOMES NORTHERN CALIFORNIA, INC, RETREATS NORTH AND EAST PROJECT (WDID#5A34CR00693A1), SACRAMENTO COUNTY

This Order responds to the 30 September 2021 request for an amendment of the Retreats North and East Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00693).
