ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; 510 LR DEVELOPMENT, LLC, LIBERTY RANCH PROJECT (WDID NO. 5A34CR00721A4), SACRAMENTO COUNTY

This Order responds to the 20 March 2025 request for an amendment to the 510 LR Development, LLC, Liberty Ranch Project Section 401 Water Quality Certification. The original Water Quality Certification (certification) was issued on 24 July 2018 (WDID No. 5A34CR00721), an amendment to modify the compensatory mitigation requirement was issued on 13 May 2022 (WDID No. 5A34CR00721A1), an amendment to change the name of the permittee was issued on 11 July 2023 (WDID No. 5A34CR00721A2) and an amendment to extend the original expiration date of 24 July 2023 to align with the United States Army Corps of Engineers Individual Permit (SPK-2014-00131) expiration date of 3 April 2025 was issued on 21 July 2023 (WDID No. 5A34CR00721A3). The requested amendment is hereby approved, and the original Certification and previously approved amendments are therefore amended as described below. Please attach this document to the original Certification, along with its prior amendments.

AMENDMENT:

510 LR Development, LLC (hereinafter Permittee) is requesting an amendment to the Section 401 Water Quality Certification and Order to extend the expiration date of 3 April 2025 to align with the United States Army Corps of Engineers' (SPK-2014-00131) proposed expiration date of 3 April 2026. The request has been approved, and the expiration date of the Section 401 Water Quality Certification is **extended to 3 April 2026**.
