# ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; TEICHERT AGGREGATES, TEICHERT QUARRY PROJECT (WDID NO. 5A34CR00728A3), SACRAMENTO COUNTY

This Order responds to the 27 November 2023 request for an amendment to the Teichert Aggregates, Teichert Quarry Project Section 401 Water Quality Certification (WDID No. 5A34CR00728A2). The original Water Quality Certification was issued on 27 September 2018 and amendments were issued on 14 December 2018 and 27 September 2023. The requested amendment is hereby approved, and the original Certification and previously approved amendment are therefore amended as described below. Please attach this document to the original Certification.

#### AMENDMENT:

Teichert Aggregates is requesting an amendment to the Section 401 Water Quality Certification and Order to extend the original expiration date to 31 December 2028. The United States Army Corps of Engineers extended the individual permit (SPK-2003-00050) to 31 December 2033. The request has been approved and the expiration date of the Section 401 Water Quality Certification is **extended to** 31 December 2028.
