ORDER AMENDING GENERAL ORDER R5-2019-0066, WASTE DISCHARGE REQUIREMENTS AND CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION OF THE SOUTH SACRAMENTO HABITAT CONSERVATION PLAN (SSHCP) REGIONAL GENERAL PERMIT 15 (RGP15); UNITED STATES DEPARTMENT OF THE ARMY CORPS OF ENGINEERS, (WDID# 5A34CR00763A1), SACRAMENTO COUNTY

This Order responds to the 23 February 2024 request for an amendment of General Order R5-2019-0066, Waste Discharge Requirements and Clean Water Act Section 401 Water Quality Certification of the South Sacramento Habitat Conservation Plan (SSHCP) Regional General Permit 15 (WDID#5A34CR00763). The original General Order was issued on 2 August 2019. The requested amendment is hereby approved. The original General Order is therefore amended as described below. AMENDMENT:

The United States Army Corps of Engineers (USACE) is requesting a time extension of the General Order to coincide with the reissuance of USACE's Regional General Permit 15: Minimal Impact Activities Under the South Sacramento In-Lieu Fee Program (RGP 15).

The General Order is amended to be valid for the term authorized under the USACE's RGP 15. The General Order is not valid if coverage under the USACE's RGP 15 has expired or been terminated by the USACE.
