ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; PACIFIC GAS & ELECTRIC, WEST SACRAMENTO-BRIGHTON 115KV INVESTIGATIONS PROJECT (WDID#5A34CR00780A1) (SPK-2019-00548), SACRAMENTO COUNTY

This Order responds to the 4 February 2021 request for an amendment of the West Sacramento-Brighton 115kV Investigations Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00780). The original Water Quality Certification (Certification) was issued on 20 April 2020. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Pacific Gas & Electric is requesting a time extension through 18 March 2022. A time extension was authorized by the United States Army Corps of Engineers on 30 September 2020. Pacific Gas & Electric has provided documentation from the United States Army Corps of Engineers (SPK-2019-00548) authorizing in-water construction activities to continue until 18 March 2022.

The Certification is amended to extend the authorization of in-water work to reflect as approved from 1 May 2020 through 18 March 2022.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$1,638.00 for the original Certification were received on 12 December 2019. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) Choose an item with the dredge and fill fee calculator.




Figure 1: Project Location Map
