ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; CALIFORNIA STATE PARKS, COYOTE GULCH INITIAL EROSION CONTROL PRAIRIE CITY STATE VEHICLE RECREATION AREA PROJECT (WDID#5A34CR00823A1), SACRAMENTO COUNTY

This Order responds to the 5 November 2025 request for an amendment of the Coyote Gulch Initial Erosion Control Prairie City State vehicle recreation area project (Project) Section 401 Water Quality Certification (WDID#5A34CR00823). The original Water Quality Certification (Certification) was issued on 30 July 2021. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

California State Parks is requesting a time extension through 31 August 2029. A time extension was authorized by the United States Army Corps of Engineers on 19 November 2025. California State Parks has provided documentation from the United States Army Corps of authorizing in-water construction activities to continue until 31 August 2029.

The Certification is amended to extend the expiration to 31 August 2029.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$551.00 for the original Certification were received on 14 June 2021. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category D - Ecological Restoration and Enhancement Projects (fee code 85) with the dredge and fill fee calculator.
