ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; AKT SILVER SPRINGS, LLC, SILVER SPRINGS EAST PROJECT (WDID#5A34CR00836A1), SACRAMENTO COUNTY

This Order responds to the 3 January 2023 request for an amendment of the Silver Springs East Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00836). The original Water Quality Certification (Certification) was issued on 11 February 2022. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please retain this document with the original Certification for your records.

AMENDMENT:

AKT Silver Springs, LLC is requesting an alternative figure (Figure 2 – Proposed Project and Impacts to Aquatic Resources) replace the current Figure 2 on the Section 401 Water Quality Certification issued on 11 February 2022 with an updated Figure 2 submitted by AKT Silver Springs, LLC to be consistent with the United States Army Corps of Engineers (SPK-2005-00325) documentation.

The Certification is amended to replace the existing Figure 2 with the updated Figure 2.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$2,066.00 for the original Certification were received on 13 October 2021. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
