### **ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; CITY OF REDDING, EASTSIDE ROAD AT OLNEY CREEK BRIDGE REPLACEMENT PROJECT (WDID NO. 5A45CR00555A1), SHASTA COUNTY**

This Order responds to the 2 January 2024 request for an amendment to the City of Redding, Eastside Road at Olney Creek Bridge Replacement Project Section 401 Water Quality Certification (WDID No. 5A45CR00555). The original Water Quality Certification was issued on 15 January 2019. The requested amendment is hereby approved. The original Certification is therefore amended as described below. City of Redding (hereinafter Permittee) is requesting an amendment to the Section 401 Water Quality Certification and Order to extend the original expiration date of 15 January 2024 to align with the United States Army Corps of Engineers' expiration date of 14 March 2026 under 2021 Nationwide Permit 14 – Linear Transportation Projects. The request has been approved and the expiration date of the Section 401 Water Quality Certification is extended to **14 March 2026**.
