# ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; RECLAMATION DISTRICT NO. 1000, DITCH G2 OUTFALL PROJECT (WDID#5A51CR00147A1), SUTTER COUNTY

This Order responds to the 20 April 2025 request for an amendment of the Ditch G2 Outfall Project (Project) Section 401 Water Quality Certification (WDID#5A51CR00147). The original Water Quality Certification (Certification) was issued on 14 August 2024. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Reclamation District No. 1000 is requesting to include dewatering in the Project activities. Dewatering plans are included as an attachment.
