NOTICE OF APPLICABILITY: STATE WATER RESOURCES CONTROL BOARD CLEAN WATER ACT SECTION 401 GENERAL WATER QUALITY CERTIFICATION, SB18054IN, FOR REGIONAL GENERAL PERMIT 8 FOR TOM ATWOOD, 2023 STORMS 16565 REEDS CREEK ROAD EMERGENCY REPAIR PROJECT, TEHAMA COUNTY, WDID NO. 5A52CR00226

This letter serves to notify Tom Atwood the 2023 Storms 16565 Reeds Creek Road Emergency Repair Project (Project) conducted under the Army Corps of Engineers Regional General Permit 8 (RGP 8) for emergency repair and replacement activities (WDID No. 5A52CR00226) is certified under State Water Resources Control Board Clean Water Act (CWA) Section 401 General Water Quality Certification SB18054IN. The project site is located on Reeds Creek Road, at two different locations, latitude 40.17544, longitude -122.42652 and latitude 40.17479, longitude -122.42263, in Tehama County, California. This certification is for the purpose described in the Notice of Intent (NOI) and supplemental information submitted by Tom Atwood and is limited to the impacts identified in the application materials.

EMERGENCY WORK DESCRIPTION

The Project consists of placing 270 cubic yards of 2-foot to 4-foot rip rap in two different locations on an unnamed tributary of Liza Creek to stabilize the bank to protect the property from erosion and keep the structures safe above the banks. The Project will be conducted with heavy equipment that will not enter the tributary below the ordinary high water mark.
