**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; CALIFORNIA DEPARTMENT
OF TRANSPORTATION, CALAVERAS CULVERT REPLACEMENT PROJECT (EA
10-1G620) (WDID#5B05CR00121A1), CALAVERAS COUNTY**

This Order responds to the 18 March 2025 request for an amendment of the Calaveras Culvert Replacement Project (EA 10-1G620) (Project) Section 401 Water Quality Certification (WDID#5B05CR00121). The original Water Quality Certification (Certification) was issued on 1 May 2024. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

The amendment is needed to remove mercury sampling requirements. Mercury sampling will not be necessary based on the locations and scope of in water work. The Certification is amended to remove the conditions set forth in Section XIV.C.4.
