**ORDER AMENDING WATER QUALITY ORDER NO. R5-2023-0037, WASTE DISCHARGE REQUIREMENTS; RICHLAND PLANNED COMMUNITIES INC, THE RANCH IN ANTIOCH MASTER PLANNED RESIDENTIAL COMMUNITY PROJECT (WDID#5B07CR00234A1), CONTRA COSTA COUNTY**

This Order responds to the 8 May 2025 request for an amendment of Water Quality Order No. R5-2023-0037, Waste Discharge Requirements for the Ranch in Antioch Master Planned Residential Community Project (Project), WDID#5B07CR00234. The original Water Quality Order (Order) was issued on 10 August 2023. The requested amendment is hereby approved. The original Order is therefore amended as described below.
