ORDER AMENDING NOTICE OF APPLICABILITY; GENERAL SECTION 401 WATER QUALITY CERTIFICATION; MERCED IRRIGATION DISTRICT, NORTH FORK STREAM GAUGE PROJECT (WDID#5B22CR00051), MERCED COUNTY

This Order responds to the 9 September 2020 request for an amendment of the North Fork Stream Gauge (Project) Notice of Applicability (NOA) (WDID#5B22CR00051). The original NOA was issued on 25 March 2020. The requested amendment is hereby approved. The original NOA is therefore amended as described below. Please attach this document to the original NOA.

AMENDMENT:

Merced Irrigation District is requesting a time extension through 15 November 2020 and an additional work window from 1 April 2021 to 31 October 2021. Additionally, Merced Irrigation District is relocating the stream gauge from the location indicated on the original application. There are no changes in area of impacts to aquatic resources.

The NOA is amended as shown below:
