ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; EAST BAY MUNICIPAL UTILITY DISTRICT, LOWER MOKELUMNE RIVER SPAWNING HABITAT IMPROVEMENT PROJECT (WDID#5B39CR00171A1), SAN JOAQUIN COUNTY

This Order responds to the 19 April 2023 request for an amendment of the Lower Mokelumne River Spawning Habitat Improvement (Project) Section 401 Water Quality Certification (WDID# 5B39CR00171). The original Water Quality Certification (Certification) was issued on 25 August 2009. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

East Bay Municipal Utility District is requesting a time extension through 14 March 2026. A time extension was authorized by the United States Army Corps of Engineers on 20 April 2023. East Bay Municipal Utility District has provided documentation from the United States Army Corps of Engineers (SPK-2004-00591) authorizing in-water construction activities to continue until 14 March 2026.

The Certification is amended to update the expiration date of the Certification to 14 March 2026.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$640.00 for the original Certification were received on 9 August 2004. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
