ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; TUOLUMNE COUNTY DEPARTMENT OF PUBLIC WORKS, ITALIAN BAR ROAD CROSSING ROSE CREEK BRIDGE REPLACEMENTPROJECT #1628 (WDID#5B55CR00183A1), TUOLUMNE COUNTY

This Order responds to the 15 September 2025 request for an amendment of the Italian Bar Road Crossing Rose Creek Bridge Replacement Project #1628 (Project) Section 401 Water Quality Certification (WDID#5B55CR00183). The original Water Quality Certification (Certification) was issued on 7 October 2024. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

#### AMENDMENT:

Tuolumne County Department of Public Works is requesting a correction to the expiration date for the Clean Water Act Section 401 Water Quality Certification and Order. The original expiration date was incorrectly stated as 7 October 2024. The Certification is amended to reflect an expiration date of 7 October 2029.

### **APPLICATION FEE RECEIVED:**

No fee was required for this amendment. Total fees of \$3,193.00 for the original Certification were received on 12 August 2024. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
