### **ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; COUNTY OF FRESNO, FRESNO COUNTY BRIDGE SCOUR MAINTENANCE PROJECT (WDID NO. 5C10CR00068A1), FRESNO COUNTY**

This Order responds to the 16 May 2025 request for an amendment of the Fresno County Bridge Scour Maintenance (Project) Section 401 Water Quality Certification (WDID No. 5C10CR00068). The original Water Quality Certification (Certification) was issued on 7 July 2020. The County of Fresno is requesting a time extension through 14 March 2027. The County of Fresno has provided documentation from the United States Army Corps of Engineers authorizing in-water construction activities to continue until 14 March 2027 provided the Project commences or is under contract to commence before the date the nationwide permit is modified, reissued, or revoked.

The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification. This amendment is not valid until and unless an amendment to the Section 404 Permit with equivalent modifications is approved by the United States Army Corps of Engineers (USACE) or it is otherwise determined by USACE that an amendment of the 404 Permit is unnecessary.

#### **AMENDMENT:**

The Certification is amended to change the expiration date from 7 July 2025 to 14 March 2027. The time extension will allow the County of Fresno to proceed with the Project described in the original Certification.
