# NOTICE OF APPLICABILITY; GENERAL SECTION 401 WATER QUALITY CERTIFICATION ORDER REQUIREMENTS FOR THE SOUTHERN CALIFORNIA EDISON, LORAINE EMERGENCY ROAD REPAIR PROJECT (WDID# 5C15CR00135), KERN COUNTY

On 16 May 2023, the Southern California Edison (Applicant) filed a notification requesting coverage under the 9 October 2018 State Water Resources Control Board Clean Water Act Section 401 General Water Quality Certification of the United States Army Corps of Engineers (USACE) Regional General Permit 8 (General Certification Order) for the Loraine Emergency Road Repair (Project). After review of the notification and the supplemental material submitted by the Applicant, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) has determined that the Project qualifies for enrollment under this General Certification Order. The proposed activity will take place within 7.38 acres of waters of the United States.

The Central Valley Water Board is certifying this Project under United States Army Corps of Engineers Regional General Permit 8, Emergency Repair and Protection Activities, subject to the conditions and the notification requirements described in the Nationwide Permit ("Special Conditions"). This Notice of Applicability is being issued under the General Certification Order pursuant to Section 3838 of the California Code of Regulations.

The Project must proceed in accordance with the requirements contained in this Notice of Applicability and General Certification Order. The Project is described in the notification form requesting coverage under the General Certification Order, dated 16 May 2023, and supplementary information (Application Package). Coverage under the General Certification Order is no longer valid if the Project (as described) is modified.

#### PROJECT DESCRIPTION:

The Project consists of emergency road repairs to Southern California Edison access roads near Caliente Bodfish Rd and Walker Basin Rd in Kern County. The roads are critical to access electrical infrastructure. Up to 28 unnamed potential waters of the United States occur within the emergency repair area and may be affected by proposed grading and repair work. Emergency repairs from storm damage would include:

- Vegetation removal and clearing downed tree and boulder obstructions.
- Blading to remove slides and slumps.
- Grading to repair blowouts, erosion, and rutting.
- Recompacting and reinforcing undermined roads.
- Cleaning and repairing ditches, turnouts, and spur roads.
- Re-establishing berms, water bars, side drains, and water crossings.
- Returning drain inlets and overside drains to a functional state.
- Leveling and re-compacting road surfaces to remove potholes, ruts, and other unsafe surface irregularities.
- Repairing and returning into service culverts, McCarthy drains, walls, and overroad protection features.

The Project will temporarily impact 7.38 acres of waters of the United States.

#### PROJECT LOCATION:

The Project is in Kern County approximately 33 miles northeast of the City of Bakersfield. The Southern California Edison access roads are accessible from Caliente Bodfish Rd and Walker Basin Rd.

#### PROJECT SCHEDULE:

The approximate timeframe of Project construction is May 2023 through October 2023.

#### APPLICATION FEE RECEIVED:

An application fee of \$2,734.00 was received on 15 May 2023.

The fee amount was determined as required by California Code of Regulations, title 23, sections 3833(b)(3) and 2200(a)(3), and was calculated as category F - Emergency Projects authorized by a Water Board General Order (fee code 85) with the dredge and fill fee calculator.
