APPROVING THE INDUSTRIAL PRETREATMENT PROGRAM  
FOR  
EL DORADO IRRIGATION DISTRICT  
EL DORADO HILLS WASTEWATER TREATMENT PLANT  
AND  
DEER CREEK WASTEWATER TREATMENT PLANT  
EL DORADO COUNTY

WHEREAS, the United States Environmental Protection Agency (USEPA) promulgated General Pretreatment Regulations for Existing and New Sources of Pollution, codified in Title 40, Code of Federal Regulations (CFR), Part 403; and

WHEREAS, the State Water Resources Control Board and California Regional Water Quality Control Boards received approval authority from the USEPA to administer the General Pretreatment Regulations on 25 September 1989; and

WHEREAS, on 31 January 2013, the California Regional Water Quality Control Board, Central Valley Region (hereafter Central Valley Water Board) adopted Waste Discharge Requirements Order R5-2013-0003 for the El Dorado Irrigation District (District) El Dorado Hills Wastewater Treatment Plant; and

WHEREAS, on 6 June 2014, the Central Valley Water Board adopted Waste Discharge Requirements Order R5-2014-0081 for the District's Deer Creek Wastewater Treatment Plant; and

WHEREAS the WDRs require that the District implement and comply with all pretreatment requirements contained in 40 CFR, Part 403, including implementing the necessary legal authorities; and

WHEREAS, the District requested approval of its Industrial Pretreatment Program in accordance with 40 CFR, Part 403.9, *et seq.*; and

WHEREAS, on 7 October 2016, the District adopted a revised ordinance implementing the Industrial Pretreatment Program; and

WHEREAS, the District's proposed legal authority meets the legal authority requirements contained in 40 CFR, Part 403; and

WHEREAS, the Central Valley Water Board notified the District and interested parties of its intent to approve the District's Industrial Pretreatment Program and provided them with an opportunity for public hearing and an opportunity to submit comments and recommendations; and

WHEREAS, the Central Valley Water Board, in a public meeting, heard and considered all comments pertaining to this action:

Therefore, be it RESOLVED, that the Central Valley Water Board, hereby approves the Industrial Pretreatment Program submitted by the El Dorado Irrigation District.
