ORDER R5-2013-0162

**RESCINDING WASTE DISCHARGE REQUIREMENTS**

a) **CERTAINTEED CORPORATION, CHOWCHILLA WASTEWATER TREATMENT FACILITY, MADERA COUNTY**

Waste Discharge Requirements Order 90-085, adopted on 23 March 1990, prescribes requirements for the discharge from the CertainTeed Corporation's wastewater treatment facility located in Chowchilla. The CertainTeed Corporation applied for coverage under Water Quality Order 97-10-DWQ, and a Notice of Applicability was issued on 14 October 2013. Therefore, WDRs Order 90-085 are no longer necessary and should be rescinded. (LR)

b) **EQUITY OFFICE MANAGEMENT, L.L.C AND M&H PROPERTY MANAGEMENT ARDEN SQUARE SHOPPING CENTER POTASSIUM PERMANGANATE INJECTION AND RECIRCULATION SYSTEM SACRAMENTO COUNTY**

Waste Discharge Requirements Order R5-2004-0082, adopted on 4 June 2004 prescribes the requirements for the discharge to groundwater of potassium permanganate mixed with water to destroy tetrachloroethylene pollution in groundwater by in-situ chemical oxidation at the Arden Square Shopping Center in Sacramento County. Injections of potassium permanganate were completed in compliance with the order in 2008 and the site has since been monitored to demonstrate continued attenuation of the groundwater pollution following stopping active remediation. Since discharges under WDR Order R5-2004-0082 have been discontinued, and there are no future plans for groundwater injections, it is appropriate to rescind WDR Order R5-2004-0082. (NC)

c) **MARINE MAGNESIUM COMPANY, SONORA SITE POST CLOSURE MAINTENANCE OF LANDFILLS, TUOLUMNE COUNTY**

Waste Discharge Requirements Order No. 96-244, adopted 20 September 1996, prescribes waste discharge requirements for post-closure maintenance of eight waste management units (WMU's) located at the former Marine Magnesium Company's site in Tuolumne County. The WMU's have been closed and all waste associated with this Order has been removed from the site or isolated in the WMU's according to the terms of the Order. The site has not been in operation since the issuance of the Order. The facilities that generated the wastes have been dismantled and removed, and there is no indication that further operations will continue. The WMU's have been closed and maintained in accordance with the Order, and a deed restriction has been filed with the Tuolumne County Recorder's Office to ensure that the presence of these WMU's will be disclosed in any future transfers of title and will remain undisturbed. Because there are no further industrial operations at this site and no observed threat to water quality, the WDR's are no longer necessary and Order 96-244 should be rescinded. (PG)

**d) TRACK FOUR, INC. (A WHOLLY OWNED SUBSIDIARY OF AMSTED INDUSTRIES INC.) AND MERCK & CO., INC. FORMER BALTIMORE AIRCOIL COMPANY FACILITY MERCED COUNTY**

Waste Discharge Requirements Order R5-2011-0006, adopted on 3 February 2011 prescribes the requirements for the discharge to land of water and carbon source amendments to treat soil pollution by reducing hexavalent chromium to trivalent chromium at the former Baltimore Aircoil Facility in Merced County. Injections were completed in compliance with the WDRs until June 2012, when the limits of the technology to clean up soil pollution at the site had been reached. Cleanup of remaining soil pollution will continue under a different process which may require new WDRs depending on the technology used. Monitoring of groundwater beneath soil injection area will continue under a separate Monitoring and Reporting Order. Since discharges under WDR Order R5-2011-0006 have been discontinued, and there are no future plans for soil injections, it is appropriate to rescind WDR Order R5-2011-0006. (NC)

IT IS HEREBY ORDERED that the above WDR orders are rescinded.
