ORDER R5-2019-0040

**RESCINDING WASTE DISCHARGE REQUIREMENTS/NPDES PERMITS/TIME SCHEDULE
ORDERS**

The California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board), finds that the Central Valley Water Board adopted the following Orders which are no longer applicable for the reasons shown:

- a. **BELL CARTER OLIVE COMPANY INC., PLANT 2, TEHAMA COUNTY**
Waste Discharge Requirements Order 94-195, adopted on 24 June 1994, prescribes requirements for the discharge from the Bell Carter Olive Company Inc. Plant 2, Tehama County (Facility). The Facility is comprised of a subsurface disposal field for the discharge of non-contact cooling water. The Facility is now regulated under Resolution R5-2018-0085 (Waiver) for Specific Types of Discharge to Land Within the Central Valley Region. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 94-195.
- b. **CALIFORNIA DEPARTMENT OF CORRECTIONS, DEUEL VOCATIONAL INSTITUTION, FIRE PIT AREA GROUNDWATER REMEDIATION, SOIL REMEDIATION CONTAINMENT AREA, SAN JOAQUIN COUNTY**
The California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board), finds that the Central Valley Water Board adopted the following Orders which are no longer applicable for the reasons shown:

Order No. R5-2002-0146, adopted 19 July 2002, prescribes requirements for a discharge of treated groundwater to the land surface and sampling of soil to be excavated at Deuel Vocational Institution, San Joaquin County. The discharge of treated groundwater to the surface has ceased, and soil excavation was determined not to be necessary and was never performed.
- c. **HEATHER GLENN MOBILE HOME PARK COMMUNITY SERVICE DISTRICT, HEATHER GLENN MOBILE HOME PARK WASTEWATER TREATMENT FACILITY, PLACER COUNTY**
Waste Discharge Requirements Order 93-065, adopted on 21 May 1993, prescribes requirements for the discharge of domestic wastewater for the Heather Glen Mobile Home Park Wastewater Treatment Facility in Placer County. The facility consists of wastewater ponds and a septic and leach-field system. Central Valley Region Water Quality Control Board received a Report of Waste Discharge, dated 10 July 2017, from the Discharger requesting coverage under the Statewide General Order 2014-0153-DWQ for Small Domestic Wastewater Treatment Systems. Regulation of the discharge was enrolled for coverage under General Order WQ 2014-0153-DWQ-R5292 on 10 January 2019. Therefore, it is appropriate to rescind Order 93-065.
- d. **SAN ANDREAS SANITARY DISTRICT, WASTEWATER TREATMENT FACILITY, CALAVERAS COUNTY**
The San Andreas Sanitary District (Discharger) is the owner and operator of the San Andreas Sanitary District Wastewater Treatment Plant (Facility), located at 675 Gold Oak Road, San Andreas, California. Waste Discharge Requirements Order R5-2014-0104-01 (NPDES CA0079464), adopted 8 August 2014, by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) prescribed requirements for the discharge of disinfected, tertiary equivalent wastewater from the Facility to the North Fork Calaveras River, a water of the United States, in Calaveras County. Time Schedule Order R5-2014-0900-01, adopted by the Central Valley Water Board on 15 January 2014, as amended by Order R5-2016-0067 on 19 August 2016, provides a compliance schedule and interim effluent limitations for cyanide with compliance required by 30 November 2018. To comply with TSO R5-2014-0900-01, the Discharger conducted a mixing zone study that indicates the North Fork Calaveras River contains assimilative

capacity for cyanide. Therefore, current Waste Discharge Requirements Order R5-2018-0075 provided dilution in the development of the effluent limits for cyanide. The Discharger is able to immediately comply with the new effluent limitations for cyanide contained in Order R5-2018-0075 and therefore Time Schedule Order R5-2014-0900-01 is no longer necessary and is rescinded.

e. **SIERRA COUNTY SERVICE AREA 5 ZONE 5A, SIERRA BROOKS SUBDIVISION, EXEMPTION FOR AN ENGINEERED RESIDENTIAL WASTEWATER DISPOSAL SYSTEM FOR SIERRA BROOKS SUBDIVISION, 121 SMITHNECK ROAD, SIERRA COUNTY**

Resolution R5-2003-0162, adopted on 17 October 2003, contains requirements for an exemption for an engineered residential wastewater disposal system located at 121 Smithneck Road in the Sierra Brooks Subdivision in Sierra County. Discharges from wastewater disposal systems for the Sierra Brooks Subdivision were regulated under Order 85-039. Regulation for the Sierra Brooks Subdivision was recently transferred to Sierra County Environmental Department under their Local Area Management Plan (LAMP), Order R5-2018-0060, which was adopted by the Central Valley Water Board on 2 August 2018. Order 85-039 was rescinded at the 8 February 2019 Board meeting. Therefore, it is appropriate to rescind Resolution R5-2003-0162 because all wastewater systems for the subdivision are now regulated under the Sierra County LAMP.

f. **SIERRA COUNTY SERVICE AREA 5 ZONE 5A, SIERRA BROOKS SUBDIVISION, EXEMPTION FOR AN ENGINEERED RESIDENTIAL WASTEWATER DISPOSAL SYSTEM FOR SIERRA BROOKS SUBDIVISION, 615 BEAR VALLEY ROAD, SIERRA COUNTY**

Resolution R5-2018-0065, adopted on 2 August 2018, contains requirements for an exemption for an engineered residential wastewater disposal system located at 615 Bear Valley Road in the Sierra Brooks Subdivision in Sierra County. Discharges from wastewater disposal systems for the Sierra Brooks Subdivision were regulated under Order 85-039. Regulation for the Sierra Brooks Subdivision was recently transferred to Sierra County Environmental Department under their Local Area Management Plan (LAMP), Order R5 2018 0060, which was adopted by the Central Valley Water Board on 2 August 2018. Order 85-039 was rescinded at the 8 February 2019 Board meeting. Therefore, it is appropriate to rescind Resolution R5-2018-0065 because all wastewater systems for the subdivision are now regulated under the Sierra County LAMP.

g. **SIERRA COUNTY SERVICE AREA 5 ZONE 5A, SIERRA BROOKS SUBDIVISION, EXEMPTION FOR AN ENGINEERED RESIDENTIAL WASTEWATER DISPOSAL SYSTEM FOR SIERRA BROOKS SUBDIVISION, 967 SIERRA BROOKS DRIVE, SIERRA COUNTY**

Resolution R5-2007-0108, adopted on 2 August 2007, contains requirements for an exemption for an engineered residential wastewater disposal system located at 967 Sierra Brooks Drive in the Sierra Brooks Subdivision in Sierra County. Discharges from wastewater disposal systems for the Sierra Brooks Subdivision were regulated under Order 85-039. Regulation for the Sierra Brooks Subdivision was recently transferred to Sierra County Environmental Department under their Local Area Management Plan (LAMP), Order R5 2018 0060, which was adopted by the Central Valley Water Board on 2 August 2018. Order 85-039 was rescinded at the 8 February 2019 Board meeting. Therefore, it is appropriate to rescind Resolution R5-2007-0108 because all wastewater systems for the subdivision are now regulated under the Sierra County LAMP.

h. **THIARA BROTHERS FARMS, BUTTE COUNTY**

Waste Discharge Requirements Order 98-181, adopted on 11 September 1998, prescribes requirements for the discharge from Thiara Brothers Farms, Butte County (Facility). The Facility is comprised of a dipper for rinsing plums for drying, with rinse water disposal to the adjacent filed for flood irrigation. The Facility is now regulated under Resolution R5-2015-0005 (Waiver) for Small Food Processors, Wineries, and Related Agricultural Processors within the Central Valley Region. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 98-181.

i. **U.S. DEPARTMENT OF THE INTERIOR, BUREAU OF RECLAMATION, NEW MELONES LAKE GLORY HOLE RECREATION AREA, CALAVERAS COUNTY**

Waste Discharge Requirements Order No. R5-2002-0125, adopted on 7 June 2002, prescribes requirements for the discharge of wastewater from the New Melones Lake Glory Hole Recreation

Area (Facility) located 2.1 miles south of the intersection of Whittle Road and Highway 44 in Angels Camp, Calaveras County. The Facility is owned and operated by the U.S. Department of the Interior, Bureau of Reclamation (Discharger). The Facility treats domestic wastewater from 144 camp sites. The design flow of the Facility is 40,000 gallons per day (gpd), but actual flows have been much less (e.g., 2,400 gpd in 2017). The Facility consists of eight sewage lift stations; two lined evaporation ponds operated in series; a liquid hypochlorite disinfection system; and a 4.8-acre spray irrigation field. On 12 January 2018, the Central Valley Water Board received a Report of Waste Discharge for coverage under State Water Resources Control Board General Order 2014-0153-DWQ for General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems. A Notice of Applicability was issued to the Discharger on 12 December 2018, assigning enrollee number 2014 0153 DWQ R5273 for the Facility. Therefore, it is appropriate to rescind Waste Discharge Requirements Order R5-2002-0125.

IT IS HEREBY ORDERED that the above Orders are rescinded on the date of this order unless otherwise stated above.
