# NOTICE OF APPLICABILITY

### WAIVER OF REPORT OF WASTE DISCHARGE AND WASTE DISCHARGE REQUIREMENTS FOR SPECIFIC TYPES OF DISCHARGE WITHIN THE CENTRAL VALLEY REGION, TRUCKEE DONNER LAND TRUST, INC., WEBBER LAKE CAMPGROUND WELL PUMP TEST, SIERRA COUNTY

On 7 June 2019, Truckee Donner Land Trust, Inc. submitted a Notice of Intent (NOI) to obtain coverage under the *Waiver of Report of Waste Discharge and Waste Discharge Requirements for Specific Types of Discharge within the Central Valley Region, Order R5-2018-0085* (the Waiver). The submittal contains all the information required to evaluate the applicability of the Waiver; therefore, the NOI is considered complete and the discharge meets the conditions of the Waiver. The discharge is hereby covered under Order R5-2018-0085-0011. Please include this number on all correspondence related to this discharge.

## **PROJECT LOCATION AND DESCRIPTION**

Donner Lake Land Trust, Inc. (Discharger) is planning on performing a well pumping test on a domestic well to be added to the Webber Lake Campground water supply system. The campground is located at Highway 89/Fiberboard Road in Sierraville, California. The domestic well will be tested for approximately 4 to 10 days. The well would be discharging approximately 10 gallons per minute for an estimated 6 hours per day; a total of 3,600 gallons per day will be applied to land. The total discharge is estimated at 14,400 to 36,000 gallons.

The well water will be discharged to 3.25 acres of open forest land owned by the Discharger. The water will be allowed to infiltrate, and best management practices will be used to minimize runoff, such as the use of straw waddles, straw bales, and/or silt fencing.

The Water Quality Control Plan for the Sacramento River and San Joaquin River Basins, Fourth Edition, revised October 2011 (hereafter Basin Plan), designates beneficial uses, establishes water quality objectives, contains implementation plans and policies for protecting waters of the basin, and incorporates by reference plans and policies adopted by the State Water Resources Control Board. Pursuant to §13263(a) of the California Water Code (CWC), waste discharge requirements must implement the Basin Plan.

## FACILITY-SPECIFIC REQUIREMENTS

Please review the attached waiver documents and ensure that the discharge complies with the Conditions of Discharge contained in Attachment A. The Discharger is responsible for compliance with the waiver and must provide sufficient contractor oversight to ensure compliance and prompt reporting of any noncompliance.
