NOTICE OF APPLICABILITY

CENTRAL VALLEY WATER BOARD RESOLUTION R5-2018-0085, APPROVING WAIVER OF REPORTS OF WASTE DISCHARGE AND WASTE DISCHARGE REQUIREMENTS FOR SPECIFIC TYPES OF DISCHARGE WITHIN THE CENTRAL VALLEY REGION; DOLE PACKAGED FOODS, LLC; AGRICULTURAL COMMODITY WASTE; MERCED COUNTY

On 1 August 2019, Dole Packaged Foods, LLC (or Discharger) submitted a Report of Waste Discharge (RWD) for coverage under Resolution R5-2018-0085, *Approving Waiver of Reports of Waste Discharge and Waste Discharge Requirements for Specific Types of Discharge Within the Central Valley Region* (or Low Threat Waiver). After review of the RWD and supplemental material submitted by the Discharger, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) has determined that the recurring application of peach pits for use as a soil amendment and dust control on dirt roads as described in the RWD qualifies for enrollment under the Low Threat Waiver. A check for the application fee was received on 9 August 2019.

Therefore, the discharge to land, as described in the RWD, qualifies for coverage under Category 9 for recurring discharges of agricultural commodity waste as described in the Low Threat Waiver. You are hereby assigned **enrollee number R5-2018-0085-0022**. Please include this number on all correspondence related to this discharge.

A copy of the Low Threat Waiver is enclosed. You can also find a copy of the Low Threat Waiver <u>R5-2018-0085</u> on the Central Valley Water Board's website at: https://www.waterboards.ca.gov/centralvalley/board_decisions/adopted_orders/waivers/r5-2018-0085.pdf.

Coverage under the Low Threat Waiver R5-2018-0085 is valid until **7 December 2023**. Prior to this date, the Discharger shall contact the Central Valley Water Board and either cease the discharge or submit a new RWD and application fee to continue under a renewed waiver or to obtain individual waste discharge requirements.

PROJECT DESCRIPTION

The Dole Package Frozen Food Plant (Plant) near Atwater processes apricots, cantaloupes, melons, peaches, strawberries, and carrots for consumer use. The pits removed from peaches during processing operations are considered an agricultural commodity waste. According to the RWD, peach pits generated at the Plant will be collected and taken to various ranches within Merced County where it will be spread along orchard rows and dirt roads for use as dust control. According to the Discharger, spreading operations will take place between July and October of each year. The ranch owner or manager will direct the driver to various roads within the property where dust control is needed. Care will be taken to evenly spread the material over the roads and ensure there is no runoff into surface waters or drainage courses. Application areas within the ranch properties will be alternated about every other year.

PROJECT LOCATION

The Dole Package Frozen Food Plant is at 7919 West Bellevue Road near Atwater in Merced County. According to the RWD the application areas will include the Atwater Ranch, the Fisher Ranch, and Los Cerritos Ranch on land owned by Dole Packaged Foods, LLC. Peach pits will also be applied to dirt roads on land owned by Mr. Billy Grissom and Mr. Tony Homen. The RWD includes signed agreements from both Billy Grissom and Tony Homen. Details on the respective application areas are provided in Table 1 below along with Assessor's Parcel Numbers. Maps showing the respective application areas are included in **Attachment A**.

SPECIFIC REQUIREMENTS

- 1. Application of agricultural commodity waste at a location or in a manner different from that described in the RWD and this NOA is prohibited.
- 2. The application shall not cause or threaten to cause conditions of contamination, nuisance, or pollution as defined in California Water Code section 13050.

- 3. Application of agricultural commodity waste or runoff from storage and/or application areas to adjacent lands, surface waters, or surface water drainage courses is prohibited.
- 4. Failure to abide by the conditions of the Low Threat Waiver R5-2018-0085, and this NOA could result in enforcement actions, as authorized by provisions of the California Water Code.

FIGURE 1 – Atwater Ranch





FIGURE 2 – Fisher Ranch






FIGURE 3 – Los Cerritos Ranch




FIGURE 4 – Billy Grissom Properties




FIGURE 5 – Tony Homen Properties
