NOTICE OF APPLICABILITY

WAIVER OF REPORT OF WASTE DISCHARGE AND WASTE DISCHARGE REQUIREMENTS FOR SPECIFIC TYPES OF DISCHARGE WITHIN THE CENTRAL VALLEY REGION,
PILLSBURY ROAD PARTNERS, LLC.,
GRIFFIN PARK SUBDIVISION, PHASE B UNIT 7

On 28 September 2022, Knife River Construction on behalf of Pillsbury Road Partners, LLC. submitted a Notice of Intent to obtain coverage under the Waiver of Report of Waste Discharge and Waste Discharge Requirements for Specific Types of Discharge within the Central Valley Region, Order R5-2018-0085 (the Waiver). The submittal contains all the information required to evaluate the applicability of the Waiver; therefore, the NOI is considered complete and the discharge meets the conditions of the Waiver. The discharge is hereby covered under the Waiver, Order R5-2018-0085-0077. Please include this number on all correspondence related to this discharge.

Project Location and Description

Pillsbury Road Partners, LLC. (Discharger) is constructing a new subdivision (Griffin Park Subdivision) located near Tinnin Road and Woodward Ave in Manteca, California. During excavation activities for the installation of underground sewer, storm, and water lines, groundwater dewatering will be necessary. Temporary dewatering wells will be used, and the extracted water will be discharged on-site to a temporary drainage basin. Approximately 1.0 million gallons of water will be discharged a day. Discharges associate with the project is expected to be completed in Spring 2023. The discharge will remain on-site and will not impact any surface water bodies.

The Water Quality Control Plan for the Sacramento River and San Joaquin River Basins, Fifth Edition, revised May 2018, establishes water quality objectives, contains implementation plans and policies for protecting waters of the basin, and incorporates by reference plans and policies adopted by the State Water Resources Control Board. Pursuant to §13263(a) of the California Water Code (CWC), waste discharge requirements must implement the Basin Plan.
